1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to cancel operative/non-operative extension and show Petitioner reenlisted on 17 January 2022 for 3 years and was eligible for and received a Selective Reenlistment Bonus (SRB).

2. The Board, consisting of ██████████, ██████████, and ██████████ reviewed Petitioner's allegations of error and injustice on 9 November 2023 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. On 14 January 2015, Petitioner entered active duty for 4 years with an End of Active Obligated Service (EAOS) of 13 January 2019 and Soft EAOS (SEAOS) of 13 January 2021; "Training in the nuclear field. MILPERSMAN 1510-030 and MILPERSMAN 1306-500, 1306-502, and 1306-504(NF) are governing directives. advancement to rate and grade per MILPERSMAN 1430-010. I understand this extension of active service becomes binding upon execution, and thereafter may not be cancelled, except as set forth in MILPERSMAN 1160-040 and 1510-030. In particular, I understand that when I accept advancement to E4, 12 months of

this agreement may not be cancelled whether or not I complete nuclear power or advanced training.”

- b. On 24 January 2017, Petitioner transferred from [REDACTED], and arrived to [REDACTED] on 3 March 2017 for duty.
- c. On 4 August 2017, Petitioner reenlisted for 6 years with an EAOS of 3 August 2023 and received a Zone A SRB.
- d. On 6 April 2018, Petitioner got married. On [REDACTED], Petitioner’s first child was born.
- e. On 15 July 2019, Petitioner transferred from [REDACTED], and arrived to [REDACTED] on 27 July 2019 for duty.
- f. In accordance with reference (b), this NAVADMIN announced revised SRB policy for Active Component and Full Time Support, superseding NAVADMIN 272/19. Sailors must now have reenlisted within 365 days of their EAOS (as opposed to 270 days required in NAVADMIN 272/19), except in the case of Nuclear-trained Sailors who could have reenlisted at any point in the reenlistment zone, per guidance in OPNAVINST 1160.8B.
- g. In September 2020, Petitioner was awarded Navy Enlisted Classification (NEC) N15S.
- h. In accordance with reference (c), FY21 SRB Award Plan (N13SRB 001/FY21) a Zone “B” SRB with an award level of 8.5 (\$100,000 award ceiling) for the MMN(SS)/N15O/S rate/NEC was listed.
- i. On 10 November 2020, Petitioner was issued official change duty orders (BUPERS order: [REDACTED]) with required obligated service to April 2024, while stationed in [REDACTED], [REDACTED], [REDACTED] with an effective date of departure of March 2021. Petitioner’s ultimate activity was [REDACTED], [REDACTED], [REDACTED] for duty with an effective date of arrival of 15 April 2021 with a projected rotation date of April 2024. Obligated service to April 2024 is required for this assignment which may be satisfied by reenlistment or extension of enlistment. Circumstances such as potential monetary loss under critical skills bonus or SRB, refer to MILPERSMAN 1306-106. para 4. Use of NAVPERS 1070/613 only authorized for SRB eligible sailors.
- j. On 14 January 2021, Petitioner entered Zone B.
- k. On 27 January 2021, Petitioner signed an agreement to extend enlistment for 8 months with a SEAOS of 3 April 2024 in order to incur sufficient obligated service to execute BUPERS order [REDACTED].
- l. On 19 March 2021, Petitioner transferred from [REDACTED], and arrived to [REDACTED] on 15 April 2021 for duty.

m. On 7 May 2021, Petitioner's Master Military Pay Account shows that Petitioner's Submarine Pay stopped.

n. In accordance with reference (d), FY21 SRB Award Plan (N13SRB 005/FY21) a Zone "B" SRB with an award level of 8.5 (\$100,000 award ceiling) for the MMN(SS)/N150/S rate/NEC was listed.

o. On 30 October 2023, Petitioner's Benefits for Education Administrative Service Tool listed no dependents.

p. In the advisory opinion, attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that on 10 November 2020, Petitioner was issued official change duty orders BUPERS order: [REDACTED] with required obligated service to April 2024. At that time, a Zone B SRB was authorized in accordance with reference (c), however Petitioner was still in Zone A. On 27 January 2021, Petitioner signed an agreement to extend enlistment for 8 months to meet the OBLISERV. On 14 January 2021, Petitioner entered Zone B. The Board determined that Petitioner should have signed a NAVPERS 1070/613 vice extension of enlistment. On 17 January 2022, Petitioner would have been eligible to reenlist for 3 years and receive a Zone B SRB.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's 8-month agreement to extend enlistment (NAVPERS 1070/621) executed on 27 January 2021 is null and void.

Petitioner executed an administrative remarks (NAVPERS 1070/613) on 27 January 2021 agreeing to extend enlistment for 8 months for OBLISERV to April 2024.

Petitioner was discharged on 16 January 2022 and reenlisted on 17 January 2022 for a term of 3 years.

Note: This change will entitle Petitioner to a Zone "B" SRB with an award level of "8.5" (\$100,000 award ceiling) for the MMN(SS)/N15S rating/NEC. Remaining obligated service to 3 August 2023 will be deducted from SRB computation. Furthermore, that any other entries affected by the Board's recommendation be corrected. Contact Assistant Nuclear Enlisted Program Manager, N133D, [REDACTED], [REDACTED] concerning SRB payment.
