1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to cancel operative/non-operative extension and show Petitioner reenlisted on 22 March 2021 for 4 years and was eligible for and received a Selective Reenlistment Bonus (SRB), and was eligible to transfer education benefits to his dependents.

2. The Board, consisting of █ reviewed Petitioner's allegations of error and injustice on 16 November 2023 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. On 17 March 2015, Petitioner entered active duty for 4 years with an End of Active Obligated Service (EAOS) of 16 March 2019 and Soft EAOS (SEAOS) of 16 March 2021; "Training in the Nuclear Field Program, and advancement to E-4, per BUPERSINST 130678 AND MILPERSMAN 1160-040, 1160-080, and 1510-030. I understand that this extension becomes binding upon execution, and thereafter may not be canceled, except as set forth in MILPERSMAN 1160-040. In particular, I understand that, when I accept advancement to E-4, 12 months of this agreement may not be canceled, whether or not I complete Nuclear Power or Advanced Training."

b. On 28 August 2015, Petitioner got married.

c. On 16 December 2016, Petitioner transferred from [REDACTED] and arrived to [REDACTED] on 17 January 2017 for duty.

d. On 17 May 2017, Petitioner reenlisted for 6 years with an EAOS of 16 May 2023 and received a Zone A SRB.

e. In accordance with reference (b), this NAVADMIN announced revised SRB policy for Active Component and Full Time Support, superseding NAVADMIN 272/19. Sailors must now have reenlisted within 365 days of their EAOS (as opposed to 270 days required in NAVADMIN 272/19), except in the case of Nuclear-trained Sailors who could have reenlisted at any point in the reenlistment zone, per guidance in OPNAVINST 1160.8B.

f. In accordance with reference (c), FY20 SRB Award Plan (N13SRB 003/FY20), a Zone "B" SRB with an award level of 5.5 (\$100,000 award ceiling) for the MMN(SW)/N25O/S rate/NEC was listed.

g. In June 2020, Petitioner was awarded Navy Enlisted Classification (NEC) N25S.

h. On 21 July 2020, Petitioner was issued official change duty orders (BUPERS order: 2030) with required obligated service to May 2024, while stationed in [REDACTED] with an effective date of departure of January 2021. Petitioner's intermediate (01) activity was STU NPTU, [REDACTED] for temporary duty under instruction with an effective date of arrival of 8 February 2021. Petitioner's ultimate activity was [REDACTED] for duty with an effective date of arrival of 29 May 2021 with a projected rotation date of May 2024. Obligated service to May 2024 is required for this assignment which may be satisfied by reenlistment or extension of enlistment. Circumstances such as potential monetary loss under critical skills bonus or SRB, refer to MILPERSMAN 1306-106. para 4. Use of NAVPERS 1070/613 only authorized for SRB eligible sailors.

i. On 14 September 2020, Petitioner's child was born.

j. On 11 January 2021, Petitioner transferred from [REDACTED], and arrived to [REDACTED] on 16 February 2021 for temporary duty.

k. In accordance with reference (d), FY21 SRB Award Plan (N13SRB 003/FY21), a Zone "B" SRB with an award level of 7.5 (\$100,000 award ceiling) for the MMN(SW)/N25O/S rate/NEC was listed.

l. On 17 March 2021, Petitioner entered Zone B.

m. On 7 June 2021, Petitioner transferred from [REDACTED], and arrived to [REDACTED] on 7 June 2021 for duty.

n. On 4 October 2021, Navy Standard Integrated Personnel System (NSIPS)/Electronic Service Record (ESR) shows a 12-month agreement to extend enlistment with an SEAOS of 20 May 2024.

o. In January 2022, Petitioner was awarded NEC 805A. In August 2023, Petitioner was awarded NEC N33Z.

p. On 8 November 2023, Petitioner's Benefits for Education Administrative Service Tool listed no dependents.

q. In the advisory opinion, attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

## CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that on 21 July 2020, Petitioner was issued BUPERS order: 2030 with required obligated service to May 2024. At that time, a Zone B SRB was authorized in accordance with reference (c), however Petitioner was still in Zone A. On 17 March 2021, Petitioner entered Zone B. On 4 October 2021, NSIPS/ESR shows a 12-month agreement to extend enlistment to meet the OBLISERV. The Board determined that Petitioner should have signed a NAVPERS 1070/613 agreeing to extend enlistment vice extension of enlistment. On 22 March 2021, Petitioner would have been eligible to reenlist for 4 years and receive a Zone B SRB. Furthermore, he would have been eligible to transfer his education benefits to his dependents.

## RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's 12-month agreement to extend enlistment (NAVPERS 1070/621) operative on 17 May 2023 is null and void.

Petitioner executed an Administrative Remarks (NAVPERS 1070/613) on 4 October 2021 agreeing to extend enlistment for 12 months for OBLISERV to May 2024.

Petitioner was discharged on 21 March 2021 and reenlisted on 22 March 2021 for a term of 4 years.

Note: This change will entitle Petitioner to a Zone "B" SRB with an award level of "7.5" (\$100,000 award ceiling) for the MMN(SW)/N25S rating/NEC. Remaining obligated service to 16 May 2023 will be deducted from SRB computation. Additionally, Navy Personnel Command is authorized to align transfer education benefits with the 22 March 2021 reenlistment. Furthermore, that any other entries affected by the Board's recommendation be corrected.
