1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to show Petitioner was reimbursed for his Personally Procured Move (PPM).

2. The Board, consisting of ██████████, ██████████, and ██████████ reviewed Petitioner's allegations of error and injustice on 24 October 2023 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. On 24 July 2023, U-Haul (Equipment Contract) issued Petitioner a receipt for a 26' Moving Van.

b. On 2 August 2023, Petitioner was issued official retirement orders (BUPERS order: ██████████) while stationed in ██████████ with an effective date of departure of August 2023. Home of Selection: Deferred with an effective date of retirement of 31 August 2023.

c. Petitioner retired with an honorable character of service and was issued a DD Form 214, Certificate of Release or Discharge from Active Duty for the period of 26 April 2018 to 30 August 2023 due to Disability, Permanent.

## CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of reference (b) and enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that per reference (b), household goods allowances are based on when orders are effective and certain criteria must be met in order to execute household goods transportation before an order is issued. Petitioner was preparing to retire due to Disability, therefore Petitioner had reason to believe that official retirement orders would be forthcoming.

## RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's official retirement orders (BUPERS order: [REDACTED]) were issued on "23 July 2023" vice "2 August 2023."

A copy of this Report of Proceedings will be filed in Petitioner's naval record.
