1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to cancel operative/non-operative extension and show Petitioner reenlisted on 30 May 2023 for 4 years and was eligible for and received a Selective Reenlistment Bonus (SRB), and was eligible to transfer his education benefits to his dependents.

2. The Board, consisting of ██████████, and ██████████ reviewed Petitioner's allegations of error and injustice on 16 January 2024 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. On 22 May 2017, Petitioner entered active duty for 4 years with an End of Active Obligated Service (EAOS) of 21 May 2021 and Soft EAOS (SEAOS) of 21 May 2023; "Training in the Nuclear Field. MILPERSMAN 1510-030 and MILPERSMAN 1306-500, 1306-502, and 1306-504 (NF) are governing directives. Advancements Rate and Grade per MILPERSMAN 1430-010. I understand that this extension of active service becomes binding upon execution, and thereafter may not be cancelled, except as set forth in MILPERSMAN 1160-040 and 1510-030. In particular, I understand that when I accept advancement to E4, 12

months of this agreement may not be cancelled whether or not I complete Nuclear Power or Advanced Training.”

- b. On 14 March 2019, Petitioner transferred from [REDACTED], and arrived to [REDACTED] on 12 April 2019 for duty.
- c. In April 2019, Petitioner was awarded Navy Enlisted Classification (NEC) N14O.
- d. On 20 March 2020, Petitioner reenlisted for 6 years with an EAOS of 19 March 2026 and received a Zone A SRB.
- e. In accordance with reference (b), this NAVADMIN announced revised SRB policy for Active Component and Full Time Support, superseding NAVADMIN 272/19. Sailors must now have reenlisted within 365 days of their EAOS (as opposed to 270 days required in NAVADMIN 272/19), except in the case of Nuclear-trained Sailors who could have reenlisted at any point in the reenlistment zone, per guidance in OPNAVINST 1160.8B.
- f. In August 2021, Petitioner was awarded NEC N53Z.
- g. On 18 November 2021, Petitioner got married.
- h. In June 2022, Petitioner was awarded NEC N14S. In July 2022, Petitioner was awarded NEC T55A.
- i. In accordance with reference ©, FY23 SRB Award Plan (N13 SRB 001/FY23), a Zone “B” SRB with an award level of 8.5 (\$100,000 award ceiling) for the EMN(SS)/N14O/S rate/NEC was listed.
- j. On 31 October 2022, Petitioner was issued official change duty orders (BUPERS order: 3042) with required obligated service to September 2026, while stationed in [REDACTED] with an effective date of departure of April 2023. Petitioner’s ultimate activity was [REDACTED] for duty with an effective date of arrival of 30 May 2023 with a Projected Rotation Date of September 2026. Obligated service to September 2026 is required for this assignment which may be satisfied by reenlistment or extension of enlistment. Circumstances such as potential monetary loss under critical skills bonus or SRB, refer to MILPERSMAN 1306-106 para 4. Use of NAVPERS 1070/613 only authorized for SRB eligible sailors.
- k. On 18 April 2023, Petitioner signed an agreement to extend 6 months with an SEAOS of 19 September 2026 in order to incur sufficient obligated service to execute BUPERS order 3042.
- l. In accordance with reference (d), FY23 SRB Award Plan (N13 SRB 002/FY23), a Zone “B” SRB with an award level of 8.5 (\$100,000 award ceiling) for the EMN(SS)/N14O/S rate/NEC was listed.

m. On 27 April 2023, Petitioner's Master Military Pay Account shows that Petitioner's Submarine Pay stopped.

n. On 27 April 2023, Petitioner transferred from [REDACTED], and arrived to [REDACTED] on 30 May 2023 for duty.

o. On 22 May 2023, Petitioner entered Zone B.

p. In November 2023, Petitioner was awarded NEC 805A.

q. On 9 January 2024, Petitioner's Benefits for Education Administrative Service Tool listed no dependents.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that on 31 October 2022, Petitioner was issued BUPERS order: 3042 with required obligated service to September 2026. At that time, a Zone B SRB was authorized in accordance with reference (c), however Petitioner was still in Zone A. On 18 April 2023, Petitioner signed an agreement to extend 6 months to meet the OBLISERV. On 22 May 2023, Petitioner entered Zone B. The Board determined that Petitioner should have signed a NAVPERS 1070/613 vice extension of enlistment. On 30 May 2023, Petitioner would have been eligible to reenlist for 4 years and receive a Zone B SRB. Furthermore, Petitioner would have been eligible to transfer his education benefits to his dependents.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's 6-month agreement to extend enlistment (NAVPERS 1070/621) executed on 18 April 2023 is null and void.

Petitioner executed an Administrative Remarks (NAVPERS 1070/613) on 18 April 2023 agreeing to extend enlistment for 6 months for OBLISERV to September 2026.

Petitioner was discharged 29 May 2023 and reenlisted on 30 May 2023 for a term of 4 years.

Note: This change will entitle Petitioner to a Zone "B" SRB with an award level of "8.5" (\$100,000 award ceiling) for the EMN(SS)/N14S rate/NEC. Remaining obligated service to 19 March 2026 will be deducted from SRB computation. Additionally, Navy Personnel Command is authorized to align transfer of education benefits with the 30 May 2023 reenlistment. Furthermore, that any other entries affected by the Board's recommendation be corrected. Contact Assistant Nuclear Enlisted Program Manager, N133D, [REDACTED] concerning SRB payment.
