- 1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to cancel operative/non-operative extension and show that Petitioner reenlisted on 20 July 2023 for 3 years and was eligible for and received a Zone B Selective Reenlistment Bonus (SRB).
- 2. The Board, consisting of ______, and _____ reviewed Petitioner's allegations of error and injustice on 23 January 2024 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.
- 3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:
- a. On 14 July 2016, Petitioner entered active duty for 4 years with an End of Active Obligated Service (EAOS) of 13 July 2020 and Soft EAOS (SEAOS) of 13 July 2022; "Training in the Nuclear Field program, and advancement to E-4, per MILPER5MAN1160-040, and 1510-030. I understand that this extension becomes binding upon execution, and thereafter may not be cancelled, except as set forth in MIIPERSMAN 1160-040. In particular, I understand that, when I accept advancement to E-4, 12 months of this agreement may not be cancelled, whether or not I complete Nuclear Power or Advanced Training."

Subj: REVIEW OF NAVAL RECORD USN,	
b. In April 2018, Petitioner was awarded Navy Enlisted Classification (NEC) N15O.	
c. On 19 May 2018, Petitioner transferred from and arrived to on 19 May 2018 for duty.	
d. On 22 February 2019, Petitioner reenlisted for 6 years with an EAOS of 21 February 202 and received a Zone A SRB.	25
e. In accordance with reference (b), this NAVADMIN announced revised SRB policy for Active Component and Full Time Support, superseding NAVADMIN 272/19. Sailors must no have reenlisted within 365 days of their EAOS (as opposed to 270 days required in NAVADM 272/19), except in the case of Nuclear-trained Sailors who could have reenlisted at any point in the reenlistment zone, per guidance in OPNAVINST 1160.8B.	IN
f. On 12 June 2020, Petitioner got married.	
g. In July 2021, Petitioner was awarded NEC N15S.	
h. In accordance with reference (c), FY21 SRB Award Plan (N13SRB 005/FY21), a Zone "B" SRB with an award level of 8.5 (\$100,000 award ceiling) for the MMN(SS)/N15O/S rate/NEC was listed.	
i. On 18 November 2021, Petitioner was issued official change duty orders (BUPERS order 3221) with required obligated service to June 2025, while stationed in with an effective date of departure of March 2022. Petitioner's ultimate activity was for duty with an effective date of arrival of 15 June 2022 with a Projected Rotation Date of June 2025. Obligated service to June 2025 is required for the assignment which may be satisfied by reenlistment or extension of enlistment. Circumstances such as potential monetary loss under critical skills bonus or SRB, refer to MILPERSMAN 1306-106 para 4. Use of NAVPERS 1070/613 only authorized for SRB eligible sailors.	2
j. In January 2022, Petitioner was awarded NEC N33Z.	
k. On 15 January 2022, Navy Standard Integrated Personnel System (NSIPS)/Electronic Service Record (ESR) shows a 4-month agreement to extend enlistment with an SEAOS of 21 June 2025.	
1. On 15 May 2022, Petitioner's Master Military Pay Account shows that Petitioner's Submarine Pay stopped.	
m. On 15 May 2022, Petitioner transferred from on 13 June 2022 for duty.	

n. On 14 July 2022, Petitioner entered Zone B.

- o. In accordance with reference (d), FY23 SRB Award Plan (N13 SRB 002/FY23), a Zone "B" SRB with an award level of 8.5 (\$100,000 award ceiling) for the MMN(SS)/N15O/S rate/NEC was listed.
- p. In the advisory opinion, attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that on 18 November 2021, Petitioner was issued BUPERS order: 3221 with required obligated service to June 2025. At that time, a Zone B SRB was authorized in accordance with reference (c), however Petitioner was still in Zone A. On 15 January 2022, NSIPS/ESR shows a 4-month agreement to extend enlistment to meet the OBLISERV. On 14 July 2022, Petitioner entered Zone B. The Board determined that Petitioner should have signed a NAVPERS 1070/613 vice extension of enlistment. On 20 July 2023, Petitioner would have been eligible to reenlist for 3 years and receive a Zone B SRB.

RECOMMENDATION


That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's 4-month agreement to extend enlistment (NAVPERS 1070/621) operative on 22 February 2025 is null and void.

Petitioner executed an Administrative Remarks (NAVPERS 1070/613) on 15 January 2022 agreeing to extend enlistment for 4 months for OBLISERV to June 2025.

Petitioner was discharged 19 July 2023 and reenlisted on 20 July 2023 for a term of 3 years.

Note: This change will entitle Petitioner to a Zone "B" SRB with an award level of "8.5" (\$100,000 award ceiling) for the MMN(SS)/N15S rating/NEC. Remaining obligated service to 21 February 2025 will be deducted from SRB computation. Furthermore, that any other entries affected by the Board's recommendation be corrected.



That a copy of this report of proceedings will be filed in Petitioner's naval record.

- 4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.
- 5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of the reference, has been approved by the Board on behalf of the Secretary of the Navy.
