1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to cancel operative/non-operative extension and show that Petitioner reenlisted on 31 January 2023 for 4 years and was eligible for and received a Zone B Selective Reenlistment Bonus (SRB).

2. The Board, consisting of ██████████, ██████████, and ██████████ reviewed Petitioner's allegations of error and injustice on 23 January 2024 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. On 25 January 2017, Petitioner entered active duty for 4 years with an End of Active Obligated Service (EAOS) of 24 January 2021 and Soft EAOS (SEAOS) of 24 January 2023; "Training in the nuclear field program, and advancement to E-4, per BUPERSINST130678 and MILPERSMAN 1160-040 and 1510-030. I understand that this extension becomes binding upon execution and thereafter may not be cancelled except as set forth in MILPERSMAN 1160-040. In particular, I understand that, when I accept advancement to E-4, 12 months of this agreement may not be cancelled, whether or not I complete nuclear power or advanced training."

- b. On 16 November 2018, Petitioner transferred from [REDACTED], and arrived to [REDACTED] on 14 December 2018 for duty.
- c. In January 2019, Petitioner was awarded Navy Enlisted Classification (NEC) N13O.
- d. On 31 May 2019, Petitioner reenlisted for 6 years with an EAOS of 30 May 2025 and received a Zone A SRB.
- e. In accordance with reference (b), this NAVADMIN announced revised SRB policy for Active Component and Full Time Support, superseding NAVADMIN 272/19. Sailors must now have reenlisted within 365 days of their EAOS (as opposed to 270 days required in NAVADMIN 272/19), except in the case of Nuclear-trained Sailors who could have reenlisted at any point in the reenlistment zone, per guidance in OPNAVINST 1160.8B.
- f. In October 2020, Petitioner was awarded NEC N73Z. In May 2021, Petitioner was awarded NEC N13S. In April 2022, Petitioner was awarded NEC N33Z.
- g. In accordance with reference (c), FY22 SRB Award Plan (N13 SRB 002/FY22), a Zone “B” SRB with an award level of 9.5 (\$100,000 award ceiling) for the ETN(SS)/N13O/S rate/NEC was listed.
- h. On 27 June 2022, Petitioner was issued official change duty orders (BUPERS order: [REDACTED]) with required obligated service to May 2026, while stationed in [REDACTED], [REDACTED] with an effective date of departure of December 2022. Petitioner’s ultimate activity was [REDACTED], [REDACTED], [REDACTED] for duty with an effective date of arrival of 18 January 2023 with a Projected Rotation Date of May 2026. Obligated service to May 2026 is required for this assignment which may be satisfied by reenlistment or extension of enlistment. Circumstances such as potential monetary loss under critical skills bonus or SRB, refer to MILPERSMAN 1306-106 para 4. Use of NAVPERS 1070/613 only authorized for SRB eligible sailors.
- i. On 6 July 2022, Navy Standard Integrated Personnel System (NSIPS)/Electronic Service Record (ESR) shows a 12-month agreement to extend enlistment with an SEAOS of 30 May 2026.
- j. In accordance with reference (d), FY23 SRB Award Plan (N13 SRB 001/FY23), a Zone “B” SRB with an award level of 9.5 (\$100,000 award ceiling) for the ETN(SS)/N13O/S rate/NEC was listed.
- k. On 14 December 2022, Petitioner’s Master Military Pay Account shows that Petitioner’s Submarine Pay stopped.
- l. On 14 December 2022, Petitioner transferred from [REDACTED], and arrived to [REDACTED] on 18 January 2023 for duty.
- m. On 25 January 2023, Petitioner entered Zone B.

n. In September 2023, Petitioner was awarded NEC 805A.

o. In the advisory opinion, attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

## CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that on 27 June 2022, Petitioner was issued BUPERS order: [REDACTED] with required obligated service to May 2026. At that time, a Zone B SRB was authorized in accordance with reference (c), however Petitioner was still in Zone A. On 6 July 2022, NSIPS/ESR shows a 12-month agreement to extend enlistment to meet the OBLISERV. On 25 January 2023, Petitioner entered Zone B. The Board determined that Petitioner should have signed a NAVPERS 1070/613 vice extension of enlistment. On 31 January 2023, Petitioner would have been eligible to reenlist for 4 years and receive a Zone B SRB.

## RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's 12-month agreement to extend enlistment (NAVPERS 1070/621) operative on 31 May 2025 is null and void.

Petitioner executed an Administrative Remarks (NAVPERS 1070/613) on 6 July 2022 agreeing to extend enlistment for 12 months for OBLISERV to May 2026.

Petitioner was discharged 30 January 2023 and reenlisted on 31 January 2023 for a term of 4 years.

Note: This change will entitle Petitioner to a Zone "B" SRB with an award level of "9.5" (\$100,000 award ceiling) for the ETN(SS)/N13S rating/NEC. Remaining obligated service to 30 May 2025 will be deducted from SRB computation. Furthermore, that any other entries affected by the Board's recommendation be corrected.

The Board for Correction of Naval Records (BCNR) will not take any action with the Defense Finance and Accounting Service (DFAS) for the SRB payment. Petitioner's SRB payment will not be funded by the BCNR's Claims Line of Accounting (LOA). [REDACTED] at N133D has secured funding via unexecuted SRB funds and will use their LOA to pay the SRB payment, and will coordinate directly with the DFAS to determine Petitioner's incentive. Contact the Assistant Nuclear Enlisted Program Manager, N133D, [REDACTED]. concerning SRB payment.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.
