1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to cancel operative/non-operative extension and show that Petitioner reenlisted on 7 May 2023 for 5 years and was eligible for and received a Zone B Selective Reenlistment Bonus (SRB).

2. The Board, consisting of **Constant and Sectors**, and **Constant and Petitioner's** allegations of error and injustice on 30 January 2024 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. On 1 May 2017, Petitioner entered active duty for 4 years with an End of Active Obligated Service (EAOS) of 30 April 2021 and Soft EAOS (SEAOS) of 30 April 2023; "Training in the Nuclear Field Program and advancement to E4 per MILPERSMAN Articles 1160-040 and 1510-030. I understand that this extension becomes binding upon execution, and thereafter may not be cancelled, except as set forth in MILPERSMAN Article 1160-040. In particular, I understand that when I accept advancement to E4, 12 months of this agreement may not be cancelled whether or not I complete Nuclear Power or Advanced Training."

b. On 31 August 2018, Petitioner got married.

c. In April 2019, Petitioner was awarded Navy Enlisted Classification (NEC) N14O.

d. On 6 June 2019, Petitioner transferred from **and and the second secon**

e. On 26 June 2019, Petitioner's first child was born.

f. On 7 October 2019, Petitioner reenlisted for 6 years with an EAOS of 6 October 2025 and received a Zone A SRB.

g. In accordance with reference (b), this NAVADMIN announced revised SRB policy for Active Component and Full Time Support, superseding NAVADMIN 272/19. Sailors must now have reenlisted within 365 days of their EAOS (as opposed to 270 days required in NAVADMIN 272/19), except in the case of Nuclear-trained Sailors who could have reenlisted at any point in the reenlistment zone, per guidance in OPNAVINST 1160.8B.

h. On 8 April 2021, Petitioner's second child was born.

i. In October 2021, Petitioner was awarded NEC N14S. In December 2021, Petitioner was awarded NEC N53Z.

j. In accordance with reference (c), FY22 SRB Award Plan (N13 SRB 004/FY22), a Zone "B" SRB with an award level of 8.5 (\$100,000 award ceiling) for the MMN(SS)/N14O/S rate/NEC was listed.

k. On 15 August 2022, Petitioner was issued official change duty orders (BUPERS order: 2272) with required obligated service to May 2026, while stationed in **Example 1**,

with an effective date of departure of April 2023. Petitioner's ultimate activity was , for duty with an effective date of arrival of 25 May 2023 with a Projected Rotation Date of May 2026. Obligated service to May 2026 is required for this assignment which may be satisfied by reenlistment or extension of enlistment. Circumstances such as potential monetary loss under critical skills bonus or SRB, refer to MILPERSMAN 1306-106 para 4. Use of NAVPERS 1070/613 only authorized for SRB eligible sailors.

1. In September 2022, Petitioner was awarded NEC N33Z.

m. On 28 November 2022, Navy Standard Integrated Personnel System (NSIPS)/Electronic Service Record (ESR) shows a 7-month agreement to extend enlistment with an SEAOS of 6 May 2026.

n. In accordance with reference (d), FY23 SRB Award Plan (N13 SRB 002/FY23), a Zone "B" SRB with an award level of 8.5 (\$100,000 award ceiling) for the MMN(SS)/N14O/S rate/NEC was listed.

o. On 19 April 2023, NSIPS/ESR shows an 18-month agreement to extend enlistment with an SEAOS of 6 November 2027.

q. On 1 May 2023, Petitioner entered Zone B.

r. Petitioner's Master Military Pay Account of 25 January 2024 shows that Petitioner's Submarine Pay is being paid.

s. On 25 January 2024, Petitioner's Benefits for Education Administrative Service Tool listed an approved transaction request date of 8 September 2023 on 11 September 2023 with an obligated end date of 7 September 2027.

t. In the advisory opinion, attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that on 15 August 2022, Petitioner was issued BUPERS order: 2272 with required obligated service to May 2026. At that time, a Zone B SRB was authorized in accordance with reference (c), however Petitioner was still in Zone A. On 28 November 2022, NSIPS/ESR shows a 7-month agreement to extend enlistment to meet the OBLISERV. On 1 May 2023, Petitioner entered Zone B. The Board determined that Petitioner should have signed a NAVPERS 1070/613 vice extension of enlistment. On 7 May 2023, Petitioner would have been eligible to reenlist for 5 years and receive a Zone B SRB.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's 7-month agreement to extend enlistment (NAVPERS 1070/621) operative on 7 October 2025 is null and void.

Petitioner's 18-month agreement to extend enlistment (NAVPERS 1070/621) operative on 7 May 2026 is null and void.

Petitioner executed an Administrative Remarks (NAVPERS 1070/613) on 28 November 2022 agreeing to extend enlistment for 7 months for OBLISERV to May 2026.

Petitioner was discharged 6 May 2023 and reenlisted on 7 May 2023 for a term of 5 years.

Note: This change will entitle Petitioner to a Zone "B" SRB with an award level of "8.5" (\$100,000 award ceiling) for the EMN(SS)/N14S rating/NEC. Remaining obligated service to 6 October 2025 will be deducted from SRB computation. Furthermore, that any other entries affected by the Board's recommendation be corrected.

The Board for Correction of Naval Records (BCNR) will <u>not</u> take any action with the Defense Finance and Accounting Service (DFAS) for the SRB payment. Petitioner's <u>SRB payment will not</u> be funded by the BCNR's Claims Line of Accounting (LOA). It N133D has secured funding via unexecuted SRB funds and will use their LOA to pay the SRB payment, and will coordinate directly with the DFAS to determine Petitioner's incentive. Contact the Assistant Nuclear Enlisted Program Manager, N133D, <u>Concerning SRB payment</u>.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.

Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of the reference, has been approved by the Board on behalf of the Secretary of the Navy.
