- 1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to cancel operative/non-operative extension and show that Petitioner reenlisted on 16 November 2022 for 4 years and was eligible for and received a Zone B Selective Reenlistment Bonus (SRB), and was eligible to transfer education benefits to his dependents.
- 2. The Board, consisting of property, and previewed Petitioner's allegations of error and injustice on 30 January 2024 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.
- 3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:
- a. On 17 October 2016, Petitioner entered active duty for 4 years with an End of Active Obligated Service (EAOS) of 16 October 2020 and Soft EAOS (SEAOS) of 16 October 2022; "Training in the Nuclear Field. MILPERSMAN 1510-030 and MILPERSMAN 1306-500, 1306-502, and 1306-50 (NF) are governing directives. Advancement to Rate and Grade per MILPERSMAN 1430-010. I understand that this extension of active service becomes binding upon execution, and thereafter may not be cancelled, except as set forth in MILPERSMAN 1160-040 and 1510-030. In particular, I understand that when I accept advancement to E4, 12

months of this agreement may not be cancelled whether or not I complete Nuclear Power or Advanced Training."				
b. On 28 June 2016, Petitioner got married.				
c. In September 2018, Petitioner was awarded Navy Enlisted Classification (NEC) N23O.				
d. On 16 October 2018, Petitioner transferred from on 15 November 2018 for duty.				
e. On 25 December 2019, Petitioner reenlisted for 6 years with an EAOS 24 December 2025 and received a Zone A SRB.				
f. In accordance with reference (b), this NAVADMIN announced revised SRB policy for Active Component and Full Time Support, superseding NAVADMIN 272/19. Sailors must now have reenlisted within 365 days of their EAOS (as opposed to 270 days required in NAVADMIN 272/19), except in the case of Nuclear-trained Sailors who could have reenlisted at any point in the reenlistment zone, per guidance in OPNAVINST 1160.8B.				
g. In accordance with reference (c), FY22 SRB Award Plan (N13SRB 001/FY22), a Zone "B" SRB with an award level of 8.5 (\$100,000 award ceiling) for the ETN(SW)/N23O/S rate/NEC was listed.				
h. On 20 April 2022, Petitioner was issued official change duty orders (BUPERS order: 1102) with required obligated service to March 2026, while stationed in with an effective date of departure of October 2022. Petitioner's ultimate activity was for duty with an effective date of arrival of 16 November 2022 with a Projected Rotation Date of March 2026. Obligated service to March 2026 is required for this assignment which may be satisfied by reenlistment or extension of enlistment. Circumstances such as potential monetary loss under critical skills bonus or SRB, refer to MILPERSMAN 1306-106 para 4. Use of NAVPERS 1070/613 only authorized for SRB eligible sailors.				
i. In June 2022, Petitioner was awarded NEC N23S.				
j. On 22 September 2022, Navy Standard Integrated Personnel System (NSIPS)/Electronic Service Record (ESR) shows a 3-month agreement to extend enlistment with an SEAOS of 24 March 2026.				
k. In October 2022, Petitioner was awarded NEC N33Z.				
1. On 14 October 2022, Petitioner transferred from on 16 November 2022 for duty.				

m. On 17 October 2022, Petitioner entered Zone B.

- n. In accordance with reference (d), FY23 SRB Award Plan (N13 SRB 001/FY23), a Zone "B" SRB with an award level of 8.5 (\$100,000 award ceiling) for the ETN(SW)/N23O/S rate/NEC was listed.
 - o. In April 2023, Petitioner was awarded Navy NEC 805A.
- p. On 25 January 2024, Petitioner's Benefits for Education Administrative Service Tool listed no dependents.
- q. In the advisory opinion, attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that on 20 April 2022, Petitioner was issued BUPERS order: 1102 with required obligated service to March 2026. At that time, a Zone B SRB was authorized in accordance with reference (c), however Petitioner was still in Zone A. On 22 September 2022, NSIPS/ESR shows a 3-month agreement to extend enlistment to meet the OBLISERV. On 17 October 2022, Petitioner entered Zone B. The Board determined that Petitioner should have signed a NAVPERS 1070/613 vice extension of enlistment. On 16 November 2022, Petitioner would have been eligible to reenlist for 4 years and receive a Zone B SRB. Furthermore, Petitioner would have been eligible to transfer his education benefits to his dependents.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's 3-month agreement to extend enlistment (NAVPERS 1070/621) operative on 25 December 2025 is null and void.

Petitioner executed an Administrative Remarks (NAVPERS 1070/613) on 22 September 2022 agreeing to extend enlistment for 3 months for OBLISERV to March 2026.

Petitioner was discharged 15 November 2022 and reenlisted on 16 November 2022 for a term of 4 years.

Note: This change will entitle Petitioner to a Zone "B" SRB with an award level of "8.5" (\$100,000 award ceiling) for the ETN(SW)/N23S rating/NEC. Remaining obligated service to 24 December 2025 will be deducted from SRB computation. Additionally, Navy Personnel Command is authorized to align transfer of education benefits with the 16 November 2022 reenlistment. Furthermore, that any other entries affected by the Board's recommendation be corrected.
