1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to cancel operative/non-operative extension and show that Petitioner reenlisted on 27 April 2022 for 4 years and was eligible for and received a Zone B Selective Reenlistment Bonus (SRB).

2. The Board, consisting of [REDACTED], and [REDACTED] reviewed Petitioner's allegations of error and injustice on 13 February 2024 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. On 26 April 2016, Petitioner entered active duty for 4 years with an End of Active Obligated Service (EAOS) of 25 April 2020 and Soft EAOS (SEEOS) of 25 April 2022; "Training in the Nuclear Field. MILPERSMAN 1510-030 and MILPERSMAN 1306-500, 1306-502, and 1306-504 (NF) are governing directives. Advancement to Rate and Grade per MILPERSMAN 1430-010. I understand that this extension of active service becomes binding upon execution, and thereafter may not be cancelled, except as set forth in MILPERSMAN 1160-040 and 1510-030. In particular, I understand that when I accept advancement to E4, 12 months of this agreement may not be cancelled whether or not I complete Nuclear Power or Advanced Training."

b. In March 2018, Petitioner was awarded Navy Enlisted Classification (NEC) N15O. In May 2018, Petitioner was awarded NEC N51Z.

c. On 21 May 2018, Petitioner transferred from [REDACTED], and arrived to [REDACTED] on 6 July 2018 for duty.

d. In accordance with reference (b), this NAVADMIN announced revised SRB policy for Active Component and Full Time Support, superseding NAVADMIN 272/19. Sailors must now have reenlisted within 365 days of their EAOS (as opposed to 270 days required in NAVADMIN 272/19), except in the case of Nuclear-trained Sailors who could have reenlisted at any point in the reenlistment zone, per guidance in OPNAVINST 1160.8B.

e. On 23 April 2021, Petitioner reenlisted for 4 years with a EAOS of 22 April 2025 and received a Zone A SRB.

f. In accordance with reference (c), FY21 SRB Award Plan (N13SRB 005/FY21), a Zone "B" SRB with an award level of 8.5 (\$100,000 award ceiling) for the MMN(SS)/N15O/S rate/NEC was listed.

g. In November 2021, Petitioner was awarded NEC N15S.

h. On 1 November 2021, Petitioner was issued official change duty orders (BUPERS order: 3051) with required obligated service to July 2025, while stationed in [REDACTED] with an effective date of departure of March 2022. Petitioner's intermediate (01) activity was [REDACTED] for temporary duty under instruction with an effective date of arrival of 4 April 2022. Petitioner's ultimate activity was [REDACTED], [REDACTED] for duty with an effective date of arrival of 23 July 2022 with a Projected Rotation Date of July 2025. Obligated service to July 2025 is required for this assignment which may be satisfied by reenlistment or extension of enlistment. Circumstances such as potential monetary loss under critical skills bonus or SRB, refer to MILPERSMAN 1306-106 para 4. Use of NAVPERS 1070/613 only authorized for SRB eligible sailors.

i. In accordance with reference (d), FY22 SRB Award Plan (N13SRB 001/FY22), a Zone "B" SRB with an award level of 8.5 (\$100,000 award ceiling) for the MMN(SS)/N15O/S rate/NEC was listed.

j. In March 2022, Petitioner was awarded NEC N33Z.

k. 16 March 2022, Petitioner signed an agreement to extend enlistment for 3 months with a SEAOS of 22 July 2025 in order to incur sufficient obligated service to execute BUPERS order 3051.

l. On 6 June 2022, Petitioner's Master Military Pay Account shows that Petitioner's Submarine Pay stopped.

m. On 16 March 2022, Petitioner transferred from [REDACTED], and arrived to [REDACTED] on 5 April 2022 for temporary duty.

n. On 26 April 2022, Petitioner entered Zone B.

o. On 23 July 2022, Petitioner transferred from [REDACTED], and arrived to [REDACTED] on 23 July 2022 for duty.

p. In October 2023, Petitioner was awarded NEC 805A.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that on 1 November 2021, Petitioner was issued BUPERS order: 3051 with required obligated service to July 2025. At that time, a Zone B SRB was authorized in accordance with reference (c), however Petitioner was still in Zone A. On 16 March 2022, Petitioner signed an agreement to extend enlistment for 3 months to meet the OBLISERV. On 26 April 2022, Petitioner entered Zone B. The Board determined that Petitioner should have signed a NAVPERS 1070/613 vice extension of enlistment. On 27 April 2022, Petitioner would have been eligible to reenlist for 4 years and receive a Zone B SRB.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's 3-month agreement to extend enlistment (NAVPERS 1070/621) executed on 16 March 2022 is null and void.

Petitioner executed an Administrative Remarks (NAVPERS 1070/613) on 16 March 2022 agreeing to extend enlistment for 3 months for OBLISERV to July 2025.

Petitioner was discharged 26 April 2022 and reenlisted on 27 April 2022 for a term of 4 years.

Note: This change will entitle Petitioner to a Zone "B" SRB with an award level of "8.5" (\$100,000 award ceiling) for the MMN(SS)/N15S rating/NEC. Remaining obligated service to 22 April 2025 will be deducted from SRB computation. Furthermore, that any other entries affected by the Board's recommendation be corrected.

The Board for Correction of Naval Records (BCNR) will not take any action with the Defense Finance and Accounting Service (DFAS) for the SRB payment. Petitioner's SRB payment will not be funded by the BCNR's Claims Line of Accounting (LOA). [REDACTED] at N133D has secured funding via unexecuted SRB funds and will use their LOA to pay the SRB payment, and will coordinate directly with the DFAS to determine Petitioner's incentive. Contact the Assistant Nuclear Enlisted Program Manager, N133D, [REDACTED]. concerning SRB payment.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.
