1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to cancel operative/non-operative extension and show that Petitioner reenlisted on 13 April 2022 for 4 years and was eligible for and received a Zone B Selective Reenlistment Bonus (SRB).

2. The Board, consisting of **Constant of Action 1**, **Constant of Action 1**, and **Constant of Petitioner's** allegations of error and injustice on 12 March 2024 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. On 12 April 2016, Petitioner entered active duty for 4 years with an End of Active Obligated Service (EAOS) of 11 April 2020 and Soft EAOS (SEAOS) of 11 April 2022; Training in the Nuclear Field Program and advancement to E-4 per MILPERSMAN Articles 1160-040 and 1510-030. I understand that this extension becomes binding upon execution, and thereafter may not be cancelled, except as set forth in MILPERSMAN Article 1160-040. In particular, I understand that when I accept advancement to E-4, 12 months of this agreement may not be cancelled whether or not I complete Nuclear Power or Advanced Training.

b. On 16 November 2017, Petitioner got married.

c. In September 2018, Petitioner was awarded Navy Enlisted Classification (NEC) N16O.

d. On 24 September 2018, Petitioner transferred from **1999**, and arrived to **1999**, and arrived for duty.

e. On 26 July 2019, Petitioner reenlisted for 6 years with an EAOS of 25 July 2025 and received a Zone A SRB.

f. In accordance with reference (b), this NAVADMIN announced revised SRB policy for Active Component and Full Time Support, superseding NAVADMIN 272/19. Sailors must now have reenlisted within 365 days of their EAOS (as opposed to 270 days required in NAVADMIN 272/19), except in the case of Nuclear-trained Sailors who could have reenlisted at any point in the reenlistment zone, per guidance in OPNAVINST 1160.8B.

g. In August 2021, Petitioner was awarded NEC N16S.

h. In accordance with reference (c), FY22 SRB Award Plan (N13SRB 001/FY22), a Zone "B" SRB with an award level of 8.5 (\$100,000 award ceiling) for the MMN(SS)/N16O/S rate/NEC was listed.

i. On 12 April 2022, Petitioner entered Zone B.

j. On 27 April 2022, Petitioner was issued official change duty orders (BUPERS order: with required obligated service to December 2025, while stationed in the service of July 2022. Petitioner's intermediate (01) activity was activity was a for temporary duty under instruction with an effective date of arrival of 10 July 2022. Petitioner's ultimate activity was a for duty with an effective date of arrival of 9 December 2022 with a Projected Rotation Date of December 2025.

k. On 3 May 2022, Petitioner signed an agreement to extend enlistment for 5 months with an SEAOS of 25 December 2025 in order to incur sufficient obligated service to execute BUPERS order

l. On 6 July 2022, Petitioner's Master Military Pay Account shows that Petitioner's Submarine Pay stopped.

m. On 6 July 2022, Petitioner transferred from **Constant**, and arrived to **Constant** & on 11 July 2022 for temporary duty.

n. In November 2022, Petitioner was awarded NEC N76Z.

o. On 9 November 2022, Petitioner transferred from **2022**, and arrived to on 7 December 2022 for duty.

p. On 8 March 2024, Petitioner's Benefits for Education Administrative Service Tool listed no dependents.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that on 12 April 2022, Petitioner entered Zone B. On 27 April 2022, Petitioner was issued BUPERS order: with required obligated service to December 2025. At that time, a Zone B SRB was authorized in accordance with reference (c). On 3 May 2022, Petitioner signed an agreement to extend enlistment for 5 months to meet the OBLISERV. The Board determined that Petitioner could have reenlisted once he entered Zone B in accordance with reference (b). On 13 April 2022, Petitioner would have been eligible to reenlist for 4 years and receive a Zone B SRB. Furthermore, Petitioner would have been eligible to transfer his education benefits to his dependents.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's 5-month agreement to extend enlistment (NAVPERS 1070/621) executed on 3 May 2022 is null and void.

Petitioner was discharged 12 April 2022 and reenlisted on 13 April 2022 for a term of 4 years.

Note: This change will entitle Petitioner to a Zone "B" SRB with an award level of "8.5" (\$100,000 award ceiling) for the MMN(SS)/N16S, rating/NEC. Remaining obligated service to 25 July 2025 will be deducted from SRB computation. Additionally, Navy Personnel Command is authorized to align transfer of education benefits with the 13 April 2022 reenlistment upon Petitioner's request. Furthermore, that any other entries affected by the Board's recommendation be corrected.

The Board for Correction of Naval Records (BCNR) will <u>not</u> take any action with the Defense Finance and Accounting Service (DFAS) for the SRB payment. Petitioner's SRB payment will <u>not</u> be funded by the BCNR's Claims Line of Accounting (LOA). at N133D has secured funding via unexecuted SRB funds and will use their LOA to pay the SRB payment, and will coordinate directly with the DFAS to determine Petitioner's incentive. Contact the Assistant Nuclear Enlisted Program Manager, N133D, . concerning SRB payment.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.
