1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to cancel operative/non-operative extension and show that Petitioner reenlisted on 16 July 2022 for 4 years and was eligible for and received a Zone B Selective Reenlistment Bonus (SRB), and was eligible to transfer his education benefits to his dependents.

2. The Board, consisting of ██████████, and ██████████ reviewed Petitioner's allegations of error and injustice on 30 November 2023 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. On 6 January 2016, Petitioner entered active duty for 4 years with an End of Active Obligated Service (EAOS) of 5 January 2020 and Soft EAOS (SEAOS) of 5 January 2022; "Training in the Nuclear Field. MILPERSMAN 1510-030 and MILPERSMAN 1306-500, 1306-502, and 1306-50 (NF) are governing directives. Advancement to Rate and Grade per MILPERSMAN 1430-010. I understand that this extension of active service becomes binding upon execution, and thereafter may not be cancelled, except as set forth in MILPERSMAN 1160-040 and 1510-030. In particular, I understand that when I accept advancement to E4, 12

months of this agreement may not be cancelled whether or not I complete Nuclear Power or Advanced Training.”

b. On 16 June 2018, Petitioner reenlisted for 6 years with an EAOS of 15 June 2024 and received a Zone A SRB.

c. On 27 February 2018, Petitioner transferred from [REDACTED], and arrived to [REDACTED] on 23 March 2018 for duty.

d. In March 2020, Petitioner was awarded Navy Enlisted Classification (NEC) N14S.

e. In accordance with reference (b), this NAVADMIN announced revised SRB policy for Active Component and Full Time Support, superseding NAVADMIN 272/19. Sailors must now have reenlisted within 365 days of their EAOS (as opposed to 270 days required in NAVADMIN 272/19), except in the case of Nuclear-trained Sailors who could have reenlisted at any point in the reenlistment zone, per guidance in OPNAVINST 1160.8B.

f. In October 2020, Petitioner was awarded NEC N33Z.

g. In accordance with reference (c), FY21 SRB Award Plan (N13SRB 005/FY21), a Zone “B” SRB with an award level of 7.0 (\$100,000 award ceiling) for the EMN(SS)/N14O/S rate/NEC was listed.

h. On 29 September 2021, Petitioner was issued official change duty orders (BUPERS order: 2721) with required obligated service to July 2025, while stationed in [REDACTED], [REDACTED] with an effective date of departure of April 2022. Petitioner’s intermediate (01) activity was [REDACTED] for temporary duty under instruction with an effective date of arrival of 2 May 2022. Petitioner’s ultimate activity was [REDACTED] for duty with an effective date of arrival of 23 July 2022 with a Projected Rotation Date of July 2025. Obligated service to July 2025 is required for this assignment, which may be satisfied, by reenlistment or extension of enlistment. Circumstances such as potential monetary loss under critical skills bonus or SRB, refer to MILPERSMAN 1306-106 para 4. Use of NAVPERS 1070/613 only authorized for SRB eligible sailors.

i. On 8 April 2022, Petitioner’s Master Military Pay Account shows that Petitioner’s Submarine Pay stopped.

j. On 8 April 2022, Petitioner transferred from [REDACTED], and arrived to [REDACTED] on 3 May 2022 for temporary duty.

k. In accordance with reference (d), FY22 SRB Award Plan (N13SRB 003/FY22), a Zone “B” SRB with an award level of 8.5 (\$100,000 award ceiling) for the EMN(SS)/N14O/S rate/NEC was listed.

l. On 23 July 2022, Petitioner transferred from [REDACTED], and arrived to [REDACTED] on 23 July 2022 for duty.

- m. In August 2022, Petitioner was awarded NEC 805A.
- n. On 6 January 2022, Petitioner entered Zone B.
- o. On 2 March 2022, Petitioner signed an agreement to extend enlistment for 13 months with an SEAOS of 15 July 2025 in order to incur sufficient service to execute BUPERS order 2721.
- p. In the advisory opinion, attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following partial corrective action. The Board concluded that on 29 September 2021, Petitioner was issued BUPERS order: 2721 with required obligated service to July 2025. At that time, a Zone B SRB was authorized in accordance with reference (c), however Petitioner was still in Zone A. On 6 January 2022, Petitioner entered Zone B. On 2 March 2022, Petitioner signed an agreement to extend enlistment for 13 months to meet the OBLISERV. The Board determined that Petitioner should have signed a NAVPERS 1070/613 vice extension of enlistment. On 16 July 2022, Petitioner would have been eligible to reenlist for 4 years and receive a Zone B SRB. A review of Petitioner's record indicates he does not have any dependents for transfer of education benefits.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's 13-month agreement to extend enlistment (NAVPERS 1070/621) executed on 2 March 2022 is null and void.

Petitioner executed an Administrative Remarks (NAVPERS 1070/613) on 2 March 2022, agreeing to extend enlistment for 13 months for OBLISERV to July 2025.

Petitioner was discharged 15 July 2022 and reenlisted on 16 July 2022 for a term of 4 years.

Note: This change will entitle Petitioner to a Zone "B" SRB with an award level of "8.5" (\$100,000 award ceiling) for the EMN(SS)/N14S, rating/NEC. Remaining obligated service to 15 June 2024 will be deducted from SRB computation. Furthermore, that any other entries affected by the Board's recommendation be corrected. Contact Assistant Nuclear Enlisted Program Manager, N133D, [REDACTED] concerning SRB payment.

That part of the Petitioner's request for corrective action that exceeds the foregoing be denied. Specifically, Petitioner's record indicates he does not have any dependents for transfer of education benefits.
