1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to show Petitioner's 6-year term reenlistment of 29 September 2023 was cancelled.

2. The Board, consisting of [REDACTED], [REDACTED], and [REDACTED] reviewed Petitioner's allegations of error and injustice on 21 December 2023 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. On 16 January 2018, Petitioner entered active duty for 4 years with an End of Active Obligated Service (EAOS) of 15 January 2022.

b. On 28 October 2021, Petitioner reenlisted for 3 years with an EAOS of 27 October 2024 and received a Zone A Selective Reenlistment Bonus (SRB).

c. On 1 September 2022, Petitioner transferred from [REDACTED], and arrived to [REDACTED] on 24 September 2022 for temporary duty.

d. On 20 January 2023, Petitioner transferred from [REDACTED], and arrived to [REDACTED] on 20 February 2023 for duty.

e. On 20 July 2023, Petitioner signed a command career request (NPPSC 1160/1) requesting a 6-year reenlistment effective 29 September 2023 and an SRB Zone A. Petitioner's request was approved on 18 August 2023 by cognizant authority.

f. On 29 September 2023, [REDACTED], issued Petitioner an Administrative Remarks (NAVPERS 1070/613) that state, "Reenlisted this date. Entitled to SRB based on IT/0000 SRB zone "A". The total SRB entitlement is (\$39,323.50). First installment is (\$19,661.75)."

g. On 29 September 2023, Petitioner reenlisted for 6 years with an EAOS of 28 September 2029.

h. On 2 October 2023, Deputy Chief of Naval Personnel notified Petitioner that he was authorized immediate in-rate reenlistment in the active component with an end date of February 2025.

i. On 16 January 2024, Petitioner entered Zone B.

j. In the advisory opinion, attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that Navy Standard Integrated Personnel System shows Petitioner reenlisted for 6 years on 29 September 2023 and was approved for a Zone A SRB. After further review of his Master Military Pay Account, he was paid a Zone A for his reenlistment of 28 October 2021. Because reference (b),¹ states a member may receive only one SRB per zone during a career, the SRB for the reenlistment date of 29 September 2023 was cancelled. Petitioner will cross into Zone B on 16 January 2024 and desires to reenlist while in Zone B for SRB if offered.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's 6-year immediate reenlistment contract (NAVPERS 1070/601) executed on 29 September 2023, is null and void.

Note: This will reestablish an EAOS/Soft EAOS of 27 October 2024.

That a copy of this report of proceedings will be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the

¹ Reference (b), additional eligibility criteria will be published by NAVADMIN. If the current SRB NAVADMIN publishes the use of zones, the guidance regarding zones in table 1-1 must be adhered to. A member may receive only one SRB per zone during a career. When reenlisting for SRB, the reenlistment must take the member's new EAOS into the next SRB zone.
