1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that her naval record be corrected to show Petitioner was reimbursed for her Personally Procured Move (PPM).

2. The Board, consisting of ██████████, ██████████, and ██████████ reviewed Petitioner's allegations of error and injustice on 28 November 2023 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. On 15 June 2023, Certified Automated Truck Scales receipt was issued at ██████████, ██████████ with gross weight of 23,060 lbs.

b. On 13 July 2023, Petitioner was issued official retirement orders (BUPERS Order: 1943) while stationed in ██████████, ██████████, ██████████ with an effective date of departure of July 2023. Petitioner's home of selection: deferred with an effective date of retirement of 29 July 2023.

c. Petitioner retired with an honorable character of service and was issued a DD Form 214, Certificate of Release or Discharge from Active Duty for the period of 25 July 2006 to 28 July 2023 due to disability, permanent.

d. On 20 November 2023, NAVSUP Fleet Logistics Center Norfolk notified Petitioner that due to the move executed was prior to issuance of orders, a claim would need to be sent to the Board of Correction of Naval Record (BCNR). The information Petitioner provided was forwarded for review as well. Attached are the forms for Petitioner, along with a copy of the claim and BCNR instruction link. Petitioner was advised to forward all information to BCNR.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2) and reference (b), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that per reference (b), household goods allowances are based on when orders are effective and certain criteria must be met in order to execute household goods transportation before an order is issued. Petitioner was preparing to retire due to disability, therefore Petitioner had reason to believe that official retirement orders would be forthcoming.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's official retirement orders (BUPERS Order: 1943) were issued on "14 June 2023" vice "13 July 2023."

A copy of this report of proceedings will be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.

Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of the reference, has been approved by the Board on behalf of the Secretary of the Navy.
