Subj: REVIEW OF NAVAL RECORD OF FORMER MEMBER XXX XX USMC

1. Pursuant to the provisions of reference (a), Petitioner, a former member of the Marine Corps, filed enclosure (1) requesting his naval record be corrected in accordance with references (b) and (c). Enclosures (1) through (3) apply.

2. The Board, consisting of **Construction**, **Construction**, and **Construction**, reviewed Petitioner's allegations of error and injustice on 3 January 2024, and pursuant to its regulations, determined that the corrective action indicated below should be taken. Documentary material considered by the Board consisted of Petitioner's application together with all material submitted in support thereof, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies, to include references (b) and (c).

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. Although enclosure (1) was not filed in a timely manner, it is in the interest of justice to review the application on its merits.

c. Petitioner enlisted in the Marine Corps and began a period of active service on 23 December 2000.

d. On 1 March 2002, Petitioner disclosed to his chain of command that he was a homosexual. On 5 March 2002, Petitioner provided a signed statement indicating the same.

e. On 20 March 2002, Petitioner was notified of administrative separation processing by reason of homosexual conduct with a least favorable characterization of General (under honorable conditions) (GEN). Petitioner waived his rights to consult counsel, request a hearing before an administrative board, and to provide a statement to rebut the separation. Petitioner's Commanding Officer recommended separation with an Honorable characterization of service. The discharge authority directed a GEN character of service and, on 12 April 2002, he was so discharged.

f. Reference (c) sets forth the Department of the Navy's current policies, standards, and procedures for correction of military records following the "don't ask, don't tell" (DADT) repeal of 10 U.S.C. 654. It provides service Discharge Review Boards with the guidance to grant requests to change the characterization of service to "Honorable," narrative reason for discharge to "Secretarial Authority," SPD code to "JFF1," and reentry code to "RE-1J," when the original discharge was based solely on DADT or a similar policy in place prior to enactment of it and there are no aggravating factors in the record, such as misconduct.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of references (b) and (c), the Board concludes Petitioner's request warrants relief. The Board noted Petitioner's record supports that he was solely discharged on the basis of homosexuality with no aggravating factors. Therefore, the Board determined Petitioner is entitled to full relief under reference (c).

RECOMMENDATION

That Petitioner be issued a new DD Form 214, for the period ending 12 April 2002, indicating his character of service as "Honorable," separation authority as "MARCORSEPMAN 6214," separation code as "JFF1," narrative reason for separation as "Secretarial Authority," and reenlistment code as "RE-1A."

That no further changes be made to Petitioner's record.

That a copy of this report of proceedings be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above entitled matter.

5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulation, Section 723.6(e)) and having assured compliance with its provisions, it is hereby announced that the foregoing
