1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to show Petitioner was reimbursed for his Personally Procured Move (PPM).

2. The Board, consisting of █, █, █ reviewed Petitioner's allegations of error and injustice on 15 February 2024 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. On 30 September 2023, Certified Automated Truck Scale Company issued Petitioner a receipt at █ a gross weight of 8,280 lbs.

b. On 11 October 2023, Petitioner was issued official separation orders (BUPERS order: █) while stationed in █ with an effective date of departure of September 2023. Petitioner's place elected for travel: █ with an actual date of separation of 26 October 2023.

c. Petitioner was discharged with an honorable character of service and was issued a Certificate of Release or Discharge from Active Duty (DD Form 214) for the period of 8 March 2016 to 26 October 2023 upon completion of required active service.

d. On 15 November 2023, Petitioner was charged terminal leave for the period of 11 September 2023 to 26 October 2023 (46 days).

## CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded per reference (b) household goods allowances are based on the when orders are effective and certain criteria must be met in order to execute household goods transportation before an order is issued. Petitioner was planning to separate upon completion of required active service and was on terminal leave, therefore Petitioner had reason to believe that official separation orders would be forthcoming.

## RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's official separation orders (BUPERS order: [REDACTED]) were issued on "11 September 2023" vice "11 October 2023."

A copy of this Report of Proceedings will be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.
