1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to reflect a 4-year active duty obligation beginning 20 September 2022 with a voluntary 12-month extension for Logistics Specialist training.

2. The Board, consisting of **Construction**, **Construction**, and **Construction** reviewed Petitioner's allegations of error and injustice on 13 February 2024 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, found that, before applying to this Board, he exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board made the following findings:

a. In accordance with reference (b), the Logistics Specialist military occupational specialty requires an obligated service of 60 months; 4-year active duty obligation with voluntary 12-month extension.

b. On 24 May 2022, Petitioner enlisted in the Naval Reserve for 8 years of which 4 years was an active duty obligation. Petitioner enlisted in the Delayed Entry Program with a projected active duty service date (ADSD) of 18 July 2022. Petitioner's DD Form 1966, Record of Military Processing indicates he enlisted under the Full Time Support (FTS) Aircrew – Non Rescue Swimmer program that required 6 years of active duty service and ADSD of 20 September 2022.

c. On 20 September 2022, Petitioner entered active duty/FTS as an Airman Recruit/E-1.

d. On 2 December 2022, Petitioner completed Recruit Basic Military Training.

e. On 23 February 2023, Petitioner issued and signed NAVCRUIT 1133/52, Enlistment Guarantees – Annex "C" listed: FTS Logistics Specialist (LS) that required a 4-year active duty obligation and a voluntary extension of 12-months. Navy Standard Integrated Personnel System reflects Current Enlistment Date: 24 May 2022; End of Active Obligated Service (EAOS): 19 September 2026; and Soft EAOS: 19 May 2028.

f. On 12 May 2023, Petitioner completed Logistics Specialist Class "A" School followed by completion of Expeditionary Combat Skill course on 23 June 2023; earned Navy Enlisted Classification code 804G.

g. On 7 July 2023, Petitioner reported to **and the second se** 

h. In the advisory opinion, attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

## CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. In accordance with reference (b), the Board concluded that Petitioner's voluntary extension should have been reduced from 24-months to 12 months when he was reclassified into the LS rating. Petitioner's official military personnel file does not contain copies of his extension documents, however his electronic service record reflects erroneous contract information. Therefore, the Board determined that under this circumstance, relief is warranted.

## RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's inoperative NAVPERS 1070/621, Agreement to Extend Enlistment for 24 months on 20 September 2022 is cancelled.

Petitioner signed NAVPERS 1070/621, Agreement to Extend Enlistment for 12 months on 23 February 2023 for training in the Logistics Specialist (LS/5YO) program; the extension was certified the same day.

Note: These corrections will result in Petitioner's Soft EAOS changing to "19 September 2027" vice "19 May 2028." Furthermore, that any other entries affected by the Board's recommendation be corrected.
