- 1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to reflect education points for the August 2022 (Cycle 111) Navy Wide Advancement Examination (NWAE).
- 2. The Board, consisting of previous, and previous reviewed Petitioner's allegations of error and injustice on 6 February 2024 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.
- 3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, found that, before applying to this Board, he exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board made the following findings:
- a. In accordance with reference (b), Sailors competing for advancement to paygrades E-4 through E-6 will be awarded four points for an accredited bachelor's degree. Education points will be calculated and credited by the Joint Services Transcript (JST). Naval Education and Training Professional Development Center (NETPDC) will receive data from Navy College Management Information System for calculation into the candidates final multiple score (FMS). Requests for correction or addition to education points should be submitted to NETPDC and must include a copy of the JST. Additionally, Commanding Officers may request standard score comparison exception to policy no later than 6 months after the missed exams limiting date. The March exam limiting date is 31 December of the same year and September exam limiting date is 30 June of the next year.

c. On 22 June 2016, Petitioner entered the Navy Reserve.

- d. On 16 May 2020, Petitioner advanced to Electronics Technician Second Class (ET2)/E-5.
- e. In August 2022, Petitioner participated in the Cycle 111 NWAE and passed not advanced. Petitioner's Examination Profile Information and Exam Status sheet reflects zero education points, and FMS of 116.85.
- f. On 23 January 2024, NETPDC determined by adding four education points to Petitioner's FMS, he would have exceeded the minimum multiple required (MMR) for advancement to ET1/E-6 effective 16 June 2023.

CONCLUSION

Upon review and consideration of all the evidence of record, the Board finds the existence of an injustice warranting the following corrective action. In accordance with reference (b), Petitioner met the criteria to receive four education points; however, the points were not accounted for at the time Petitioner participated in the August 2022 (Cycle 211) NWAE. Although the proper administrative requirements were not completed, the Board determined that under this circumstance, relief is warranted.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's Examination Profile Information and Exam Status sheet from the August 2022 (Cycle 111) NWAE is modified to read Education: "4" vice "0"; FMS: "120.85" vice "119.11"; and Final Status: Selectee. Note: The MMR was 119.11.

Petitioner advanced to ET1/E-6 effective 16 June 2023 with a time in rate date of 1 January 2023.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.
