1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to show Petitioner was reimbursed for his Personally Procured Move (PPM).
2. The Board, consisting of █, █, and █ reviewed Petitioner's allegations of error and injustice on 23 January 2024 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.
3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:
 - a. On 9 May 2022, Certified Scales weight certificate was issued at █ with gross weight of 11,040 lbs.
 - b. On 27 June 2022, Petitioner was issued official Fleet Reserve orders (BUPERS Order: 1782) while stationed in █ with an effective date of departure of July 2022. Petitioner's home of selection: Deferred with an effective date of retirement of 31 July 2022.
 - c. Petitioner was transferred to the Fleet Reserve and was issued a DD Form 214, Certificate of Release or Discharge from Active Duty for the period of 25 July 1995 to 31 July 2022 upon having sufficient service for retirement.
 - d. On 28 December 2023, Petitioner's Application for Personally Procured Move and Counseling Checklist (DD Form 2278) was created listing a move from █ to █ with a maximum authorized weight of 14,000 lbs. and Estimated Government Constructive Cost of \$15,125.00; certified by a counselor.

e. On 18 January 2024, NAVSUP Fleet Logistics Center Norfolk notified the Board that Petitioner was notified that, "Paragraph 051302 A of the Joint Travel Regulation states that transportation of Household Goods (HHG) at government expenses prior to the issuance of permanent change of station orders is not authorized. Exception is made when the order issuing authority (Navy Military Personnel Command) or member designated representative provides a written statement that orders are forthcoming, and shipment may be prior to the official issuance of orders. A review of the documentation supporting the claim shows that you initiated shipment of your HHG on 9 May 2022 prior to the 27 June 2022 issue date of your orders. Since shipment was made prior to the issuance of orders, this office has no legal basis to permit payment of your claim."

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded per reference (b) HHG allowances are based on the when orders are effective and certain criteria must be met in order to execute HHG transportation before an order is issued. Petitioner was preparing to transfer to the Fleet Reserve upon having sufficient service for retirement, therefore Petitioner had reason to believe that official orders would be forthcoming.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's official Fleet Reserve orders (BUPERS Order: 1782) were issued on "8 May 2022" vice "27 June 2022."

That a copy of this report of proceedings will be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.

5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of the reference, has been approved by the Board on behalf of the Secretary of the Navy.
