# **APPLICANT'S REQUEST**

His DD Form 214, Certificate of Release or Discharge from Active Duty, be corrected to reflect award of the Global War on Terrorism Service Medal.

# APPLICANT'S CONTENTIONS

The Global War on Terrorism Service Medal was created by executive order 9 days prior to his discharge. He served on active duty for more than 30 consecutive days, supporting the Global War on Terrorism between the required dates of 11 Sep 01 to 30 Mar 04.

The applicant's complete submission is at Exhibit A.

#### STATEMENT OF FACTS

The applicant is an honorably discharged Air Force Reserve second lieutenant (O-1).

On 9 Jun 02, according to DD Form 214, the applicant entered a period of active service and on 21 Apr 03, he was discharged and credited with 10 months and 13 days of active duty service. Item 13, *Decorations, Medals, Badges, Citations and Campaign Ribbons Awarded or Authorized*, reflects the Air Force Training Ribbon and National Defense Medal.

# AIR FORCE EVALUATION

AFPC/DP3SP recommends denying the application. In accordance with AFMAN 36-2806, paragraph A14.11., the Global War on Terrorism Service Medal was established by Executive Order 13289, dated 12 Mar 03, to recognize the significant contributions of the members of the Armed Forces in support of designated War on Terrorism operations. The medal is awarded to members who participated in the War on Terrorism operations outside of the designated areas of eligibility for the Global War on Terrorism Expeditionary Medal, Afghanistan Campaign Medal, Iraq Campaign Medal, and Inherent Resolve Campaign Medal on or after 11 Sep 01 to a future date to be determined.

The applicant's official military personnel record or submission did not indicate he served in an authorized Global War on Terrorism operation. To grant relief would be contrary to the criteria established by AFMAN 36-2806.

#### APPLICANT'S REVIEW OF AIR FORCE EVALUATION

The Board sent a copy of the advisory opinion to the applicant on 5 Apr 23 for comment (Exhibit D) but has received no response.

# FINDINGS AND CONCLUSION

- 1. The application was not timely filed.
- 2. The applicant exhausted all available non-judicial relief before applying to the Board.
- 3. After reviewing all Exhibits, the Board concludes the applicant is not the victim of an error or injustice. The Board concurs with the rationale and recommendation of AFPC/DP3SP and finds a preponderance of the evidence does not substantiate the applicant's contentions. The Board also notes the applicant did not file the application within three years of discovering the alleged error or injustice, as required by Section 1552 of Title 10, United States Code, and Department of the Air Force Instruction (DAFI) 36-2603, Air Force Board for Correction of Military Records (AFBCMR). While the applicant asserts a date of discovery within the three-year limit, the Board does not find the assertion supported by a preponderance of the evidence. The Board does not find it in the interest of justice to waive the three-year filing requirement. Therefore, the Board finds the application untimely and recommends against correcting the applicant's records.

# RECOMMENDATION

The Board recommends informing the applicant the application was not timely filed; it would not be in the interest of justice to excuse the delay; and the Board will reconsider the application only upon receipt of relevant evidence not already presented.
