**APPLICANT'S REQUEST**

He be provided special board (SB) consideration for a Position Vacancy (PV) promotion to Major (0-4) for the CY 22 Air Force Reserve Line and Nonline Major PV Promotion Selection Board (U0422A).

**APPLICANT'S CONTENTIONS**

He met all the requirements for the CY22 USAFR Line and Nonline Major Position Vacancy (PV) Promotion Selection Board (U0422A) but his unit commander failed to submit his promotion recommendation (PRF) by the deadline.

In support of his contentions, the applicant provides a PRF and memoranda from his senior rater who verified that due to no fault of the applicant, the PRF was not timely submitted.

The applicant's complete submission is at Exhibit A.

**STATEMENT OF FACTS**

The applicant is an Air Force Reserve captain (0-3).

On 10 Dec 21, AF Form 709, *Promotion Recommendation*, provided by the applicant, was signed by his senior rater, and indicates that he was to be submitted for promotion consideration under the U0422A PV promotion selection board.

**AIR FORCE EVALUATION**

ARPC/PB recommends approval of the applicant's request. The applicant was eligible to meet the CY22 USAFR Line and Nonline Major PV Promotion Selection Board and has provided a signed memorandum from the applicant's senior rater, stating that due to no fault of the applicant his PRF was not submitted in a timely manner. Since the applicant was otherwise eligible to meet the PV promotion selection board and has provided a memorandum stating why his PRF was not submitted on time, his request for a special board should be approved.

**APPLICANT’S REVIEW OF AIR FORCE EVALUATION**

The Board sent a copy of the advisory opinion to the applicant on 7 Mar 22 for comment (Exhibit D), but has received no response.

**FINDINGS AND CONCLUSION**

1. The application was timely filed.
2. The applicant exhausted all available non-judicial relief before applying to the Board.
3. After reviewing all Exhibits, the Board concludes the applicant is the victim of an error or injustice. The Board concurs with the rationale and recommendation of ARPC/PB and finds a preponderance of the evidence substantiates the applicant’s contentions. Therefore, the Board recommends correcting the applicant’s records as indicated below.

**RECOMMENDATION**

The pertinent military records of the Department of the Air Force relating to APPLICANT be corrected to show that his record be considered for promotion to the grade of major by a Special Board for the CY22 Air Force Reserve (USAFR) Line and Nonline Major Promotion Vacancy (PV) Promotion Selection Board.
