APPLICANT'S REQUEST

Her Reserve Order *Work-Product* be corrected to show she served 17 years of satisfactory service.

APPLICANT'S CONTENTIONS

She served 17 good years in the Air Force Reserve and would like her discharge record to reflect the correction. To support her claim, she submitted a copy of her Points and Satisfactory Service Credit Summary, a copy of her Reserve Order, and a copy of her DD Form 214, *Certificate of Release or Discharge from Active Duty*, for the period of 19 Oct 90 to 30 Jul 91.

The applicant's complete submission is at Exhibit A.

STATEMENT OF FACTS

The applicant is a former Air Force Reserve major (O-4).

Dated 19 Dec 96, Reserve Order *WorkProduct* indicates the applicant was relieved from assignment and placed on the USAF Reserve Retired List effective 22 Nov 96. Under reason it is noted that the applicant completed eight years of satisfactory service and is not eligible for retired pay.

Dated 16 May 07, ARPC IMT 168, *Computation for Points and Satisfactory Service Credit Summary*, indicates the applicant served 16 years of satisfactory federal service.

Dated 23 Jan 23, Order *Work-Product* was published amending *Work-Product* The order was changed to reflect the applicant completed 16 years of satisfactory service. (ARPC administratively corrected the applicant's order to reflect 16 years of satisfactory service.)

APPLICABLE AUTHORITY/GUIDANCE

DoDI 1215.07, *Service Credit for Reserve Retirement*, Section 3, paragraph 3.1.a. - Pursuant to Chapter 1223 of Title 10, U.S.C., a qualifying year of creditable service toward a non-regular retirement is a full-year, as described in paragraphs 3.1.b. and 3.1.c., *Establishing and Adjusting Anniversary Years*, during which a member of an Active Component (AC) or Reserve Component (RC) is credited with at least 50 retirement points. Accumulating 20 such years, except as otherwise provided by law, is one requirement necessary to qualify for non-regular retired pay.

FINDINGS AND CONCLUSION

- 1. The application was not timely filed.
- 2. The applicant exhausted all available non-judicial relief before applying to the Board.

3. After reviewing all Exhibits, the Board concludes the applicant is not the victim of an error or injustice. The Board finds no compelling evidence to grant the applicant's request to update her Reserve Order to reflect 17 years of satisfactory service. Therefore, the Board recommends against correcting the applicant's records. The Board also notes the applicant did not file the application within three years of discovering the alleged error or injustice, as required by Section 1552 of Title 10, United States Code, and Air Force Instruction 36-2603, *Air Force Board for Correction of Military Records (AFBCMR)*. The Board does not find it in the interest of justice to waive the three-year filing requirement. Therefore, aside from the administrative correction to the Reserve Order showing 16 years of satisfactory service, the Board finds the application untimely and recommends against correcting the applicant's records.

RECOMMENDATION

The Board recommends informing the applicant the application was not timely filed; it would not be in the interest of justice to excuse the delay; and the Board will reconsider the application only upon receipt of relevant evidence not already presented.
