**APPLICANT'S REQUEST**

His DD Form 4, *Reenlistment Document – Armed Forces of the United States*, dated 11 Sep 20, Block 4, *Place of Enlistment/Reenlistment*, be corrected to reflect: Al Udeid AB, Qatar, APO AE 09309.

**APPLICANT'S CONTENTIONS**

His DD Form 4 does not reflect the correct location where his reenlistment occurred. He reenlisted while deployed, in support of Operation FREEDOM SENTINEL, to Al Udeid AB, Qatar, APO AE 09309.

The applicant's complete submission is at Exhibit A.

**STATEMENT OF FACTS**

The applicant is an Air Reserve technical sergeant (E-6).

On 11 Sep 20, according to DD Form 4, dated 11 Sep 20, applicant reenlisted in the Air Force Reserve, for a period of six years. Section D, *Certification and Acceptance*, and Section E, *Confirmation of Enlistment of Reenlistment*, reflect: 8 EAMS/Air Mobility Command, APO AE 09309.

On 7 Dec 20, according to his Air Force Achievement Medal certificate, signed by Commander, 9<sup>th</sup> Air Force (AFCENT), he was assigned to the 8<sup>th</sup> Expeditionary Air Mobility Squadron (8 EAMS), Al Udeid AB, Qatar from 9 Jun 20 to 8 Oct 20.

His *Reserve Personnel Brief*, from the Military Personnel Data System, dated 29 Apr 22, shows his date of enlistment as 11 Sep 20, and that he was deployed from 5 Jun 20 to 9 Oct 20.

**AIR FORCE EVALUATION**

AFRC/1KK recommends granting the application. Based upon documentation provided by the applicant and analysis of the facts, there is evidence of an error or injustice. The applicant's official records confirm he was deployed to Al Udeid AB, Qatar at the time of his reenlistment. Therefore, block 4 of his DD Form 4 should reflect Al Udeid AB, Qatar, APO AE 09309.

**APPLICANT’S REVIEW OF AIR FORCE EVALUATION**

The Board sent a copy of the advisory opinion to the applicant on 13 Apr 22 for comment (Exhibit D), but has received no response.

**FINDINGS AND CONCLUSION**

1. The application was timely filed.
2. The applicant exhausted all available non-judicial relief before applying to the Board.
3. After reviewing all Exhibits, the Board concludes the applicant is the victim of an error or injustice. The Board concurs with the rationale and recommendation of AFRC/A1KK and finds a preponderance of the evidence substantiates the applicant’s contentions. Therefore, the Board recommends correcting the applicant’s records as indicated below.
4. The applicant has not shown a personal appearance, with or without counsel, would materially add to the Board’s understanding of the issues involved.

**RECOMMENDATION**

The pertinent military records of the Department of the Air Force relating to the APPLICANT be corrected to show that his DD Form 4, *Reenlistment Document – Armed Forces of the United States*, dated 11 September 2020, Block 4, be amended to read “Al Udeid Air Base, Qatar APO AE 09309.”
