APPLICANT'S REQUEST

The virtual Military Personnel Flight (vMPF) and MyVector reflect his rank and duties as a master sergeant for the period 1 November 2015 to 18 August 2018.

APPLICANT'S CONTENTIONS

When he received his commission on 19 January 2019, his master sergeant promotion (effective 1 November 2015) history was omitted from his records in the vMPF and MyVector. As a result, his career data brief and other career documents do not reflect an accurate account of his military duty history. His Personnel Records Display Application (PRDA) history reflects his Enlisted Performance Reports (EPRs) and decorations related to his master sergeant rank and duties.

The applicant's complete submission is at Exhibit A.

STATEMENT OF FACTS

The applicant is a currently serving Air Force Reserve captain (O-3).

The applicant provided a report from the Military Personnel Data System (MilPDS), generated on 18 November 2022, which reflects her rank history as follows:

Airman Basic - 28 March 2007 Airman - 20 February 2008 Airman First Class - 20 August 2008 Senior Airman - 20 April 2009 Staff Sergeant - 1 May 2011 Technical Sergeant - 1 December 2012 First Lieutenant - 19 January 2019 Captain - 19 January 2021

A current MilPDS report reflects the applicant's Officer Reserve Grade History as follows:

First Lieutenant - 19 January 2019 Captain - 19 January 2021

AIR FORCE EVALUATION

AFRC/A1KK recommends denying the application. The Total Force (TF) Duty History Information Personnel Services Delivery (PSD) Guide, dated 25 September 2015, assists TF Airmen and support agencies in reviewing, changing, and correcting duty history information. IAW page 4 and table 1, officers with prior enlisted service will not have their enlisted duty history in MilPDS (duty history).

DAFI 36-2406, Officer and Enlisted Evaluations Systems, Table 11.1, line 10, duty title, refers to the Personnel Services Delivery Transformation Training – Classifications: Duty History located in myPers, which states "officers with prior enlisted service will not have their enlisted duty history in system."

Based on the documentation provided by the applicant and analysis of the facts, there is no evidence of an error or injustice. An officer's prior enlisted duty information will not be visible in the duty information/history per Air Force process and procedure. The member's applicable prior enlisted records (i.e., enlisted evaluations, decorations, etc.) will remain in the service record representing their prior enlisted experience and performance.

APPLICANT'S REVIEW OF AIR FORCE EVALUATION

The Board sent a copy of the advisory opinion to the applicant on 13 April 2023 for comment (Exhibit D) but has received no response.

FINDINGS AND CONCLUSION


- 1. The application was timely filed.
- 2. The applicant exhausted all available non-judicial relief before applying to the Board.
- 3. After reviewing all Exhibits, the Board concludes the applicant is not the victim of an error or injustice. The Board concurs with the rationale and recommendation of AFRC/A1KK and finds a preponderance of the evidence does not substantiate the applicant's contentions. Therefore, the Board recommends against correcting the applicant's records.
- 4. The applicant has not shown a personal appearance, with or without counsel, would materially add to the Board's understanding of the issues involved.

RECOMMENDATION

The Board recommends informing the applicant the evidence did not demonstrate material error or injustice, and the Board will reconsider the application only upon receipt of relevant evidence not already presented.

CERTIFICATION
