### APPLICANT'S REQUEST

The date of birth (DOB) on his DD Form 214, *Certificate of Release or Discharge from Active Duty*, be corrected.

The applicant's complete submission is at Exhibit A.

### STATEMENT OF FACTS

The applicant is a former Air Force captain (O-3).

The applicant served in the Air Force from 6 Jun 76 to 8 Oct 87, with a DOB recorded differently than the DOB on his DD Form 214.

### APPLICABLE AUTHORITY/GUIDANCE

AFI 36-2608, *Military Personnel Records System*, Table A7.5 (Correction to Date of Birth), Note 3, provides as follows: Do not correct records of former members unless evidence proves the date of birth used while serving with the Air Force was erroneously recorded. Required proof is an unaltered original document from the jurisdiction of the applicant's birth, showing the applicant's name and date of birth.

### FINDINGS AND CONCLUSION

1. The application was not timely filed, but it is in the interest of justice to excuse the delay.
2. The applicant exhausted all available non-judicial relief before applying to the Board.
3. After reviewing all Exhibits, the Board concludes the applicant is the victim of an error. The Board finds the applicant's the date of birth used while serving with the Air Force was erroneously recorded. Therefore, the Board recommends correcting the applicant's records as indicated below.

### RECOMMENDATION

The pertinent military records of the Department of the Air Force relating to APPLICANT be corrected to show that the DD Form 214, *Certificate of Release or Discharge from Active Duty*, issued in conjunction with the 8 Oct 87 discharge, be changed to reflect the correct DOB in Block 5.
