**APPLICANT'S REQUEST**

1. She be credited with ninety-two (92) days of active duty for her retirement/retention (R/R) year 22 May 03 to 21 May 04.
2. She receive active duty pay and entitlements for active duty performed from 30 June 03 to 30 Sep 03.

**APPLICANT'S CONTENTIONS**

From 30 Jun 03 to 30 Sep 03, she performed a temporary duty (TDY) tour with the Defense Intelligence Agency. While conducting a pay and points review of her record, she discovered she was never placed in an active duty status. As a result of the oversight, she only received per diem, and did not receive the eligible active duty points and pay for the TDY. She is retiring on 1 Jan 23 and is requesting ninety-three (93) active duty points be added to her R/R year 22 May 03 to 21 May 04, and back pay for active duty pay and entitlements.

The applicant's complete submission is at Exhibit A.

**STATEMENT OF FACTS**

The applicant is an Air National Guard senior master sergeant (E-8).

On 4 Sep 03, according to travel voucher order #WW308701, submitted by the applicant, she was paid \$9,093 for per diem, lodging and travel entitlements from 28 Jun 03 to 31 Aug 03, while TDY in Alexandria, VA.

On 30 Sep 03, according to AF Form 77 *Letter of Evaluation*, the applicant was assigned to the Defense Intelligence Agency from 30 Jun 03 to 30 Sep 03.

On 13 Nov 03, the applicant was awarded the Joint Service Achievement Medal for the period 30 Jun 03 to 30 Sep 03.

On 1 Jan 23, according to Special Order *Work-Product* dated 30 Mar 22, the applicant will retire with twenty four (24) months, seven (7) months, and nine (9) days.

**AIR FORCE EVALUATION**

NGB/A1PP recommends granting the application. Based on documentation provided by the applicant and analysis of the facts, there is evidence of an error or injustice. The applicant contends from 30 Jun 03 to 30 Sep 03, she performed a TDY and received per diem; however, she did not receive active duty pay and points for the period. The applicant should have been placed in an active status with a published order from the Air National Guard Reserve Order Writing System prior to participating in the TDY. As a result of not being placed in an active duty status, the applicant did not receive all applicable pay, entitlements, or one active duty point for each day she performed duty.

**APPLICANT’S REVIEW OF AIR FORCE EVALUATION**

The Board sent a copy of the advisory opinion to the applicant on 13 Sep 22 for comment (Exhibit D), but has received no response.

**FINDINGS AND CONCLUSION**

1. The application was timely filed.
2. The applicant exhausted all available non-judicial relief before applying to the Board.
3. After reviewing all Exhibits, the Board concludes the applicant is the victim of an error or injustice. The Board concurs with the rationale and recommendation of NGB/A1PP and finds a preponderance of the evidence substantiates the applicant’s contentions. Therefore, the Board recommends correcting the applicant’s records as indicated below.

**RECOMMENDATION**

The pertinent military records of the Department of the Air Force relating to APPLICANT be corrected to show that:

- a. She be awarded ninety-two (92) active duty points for the period of 30 Jun 03 through 30 Sep 03.
- b. She receive any active duty pay and entitlements not already received for her period of active duty service from 30 Jun 03 through 30 Sep 03.
