### **APPLICANT'S REQUEST**

His Fiscal Year 2021 (FY21) Aviation Bonus (AvB) Agreement for the period of 1 Sep 21 through 31 Aug 25 be approved.

### **APPLICANT'S CONTENTIONS**

Due to an administrative error, his FY21 AvB application was not uploaded to the Case Management System (CMS) in Sep 21, despite multiple confirmation attempts he made with his Force Support Squadron. He has been extremely proactive in confirming his paperwork was correct and submitted in a timely manner. This clerical error is not his fault, he signed his contract in Sep 21 and he should not be penalized for someone else's mistake.

The applicant's complete submission is at Exhibit A.

### **STATEMENT OF FACTS**

The applicant is an Air National Guard lieutenant colonel (O-5).

On 14 Sep 21, according to FY21 AvB Agreement (Statement of Understanding) provided by the applicant, he signed and requested a Tier 1, Option 1 AvB contract for \$35,000 a year for two to four years. The effective start and end date of the agreement is 1 Sep 21 to 31 Aug 25.

On 29 Jun 22, according to Order Number **Work-Product**, provided by the applicant, he was issued Full-Time National Guard Duty orders for a continuation tour from 31 Aug 21 through 31 Aug 25.

On 17 Nov 22, a pull from the Military Personnel Database System (MilPDS) provided the applicant's Point Credit Summary report, which confirms he has been on a continuous active-duty status for his Retention and Retirement (R/R) years 16 Dec 20 through 15 Dec 21 and has continued in that status through 31 Oct 22.

## **AIR FORCE EVALUATION**

NGB/A1P recommends granting the application. Based on the documentation provided by the applicant and analysis of the facts, there is evidence of an error or injustice due to process errors at the unit. On 14 Sep 21, the applicant signed a Tier 1, Option 1 agreement for four years for the period 1 Sep 21 through 31 Aug 25, at the annual rate of \$35,000 per year. While the applicant forwarded the agreement to the AvB Coordinator for review and signature, the agreement was not submitted to NGB/A1PF via the CMS until after the FY21 AvB Policy effective end date. Due to the unit AvB Coordinator's oversight, the applicant's package was not submitted in a timely manner.

## **APPLICANT'S REVIEW OF AIR FORCE EVALUATION**

The Board sent a copy of the advisory opinion to the applicant on 10 Nov 22 for comment (Exhibit D), but has received no response.

## **FINDINGS AND CONCLUSION**

1. The application was timely filed.
2. The applicant exhausted all available non-judicial relief before applying to the Board.
3. After reviewing all Exhibits, the Board concludes the applicant is the victim of an error or injustice. The Board concurs with the rationale and recommendation of NGB/A1P and finds a preponderance of the evidence substantiates the applicant's contentions. Therefore, the Board recommends correcting the applicant's records as indicated below.
4. The applicant has not shown a personal appearance, with or without counsel, would materially add to the Board's understanding of the issues involved.

## **RECOMMENDATION**

The pertinent military records of the Department of the Air Force relating to APPLICANT be corrected to show his FY21 Tier 1, Option 1 AvB agreement for the period of 1 Sep 21 through 31 Aug 25, at the rate of \$35,000 per year, be approved.
