# **APPLICANT'S REQUEST**

- 1. His NGB Form 22, *Report of Separation and Record of Service*, block 10e, Total Service for Retired Pay, be corrected.
- 2. A review of his record to ensure all time is accounted for towards retirement.
- 3. He be credited with points earned toward satisfactory service for the period 12 October 2011 to 19 July 2012 **Administratively Corrected**.

# **APPLICANT'S CONTENTIONS**

His NGB Form 22 is in error. His net service reflects six years of service; however, he only received five years total. His time in service reflects the following: 2001 to 2005 United States Navy (USN); 2005 to 2006 Navy Reserve (USNR); 2006 to 2012 New Mexico Air National Guard (NMANG); break in service 2012 to 2015; 2015 to 2021 United States Army Reserve (USAR); and 2021 to Present Air Force Reserve (AFRes). He further states, he is missing points earned toward satisfactory service for 2012.

### STATEMENT OF FACTS

The applicant is a currently serving Air Force Reserve senior airman (E-4).

On 20 July 2006, according to DD Form 4, *Enlistment/Reenlistment Document*, the applicant enlisted in the ANG.

According to the applicant's Point Credit Summary (PCARS) for the period 12 October 2011 through 19 July 2012, he was credited with 12 AD points, 40 IDT points, 12 Membership points, 64 Retirement points, and his Satisfactory Service (Year) reflects 0908.

On 19 July 2012, according to NGB Form 22, the applicant was honorably discharged in the grade of senior airman. The Authority and Reason reflects AFI 36-3209, paragraph 3.12.1 - Expiration of Enlistment. Block 10a (Net Service This Period) reflects 6 years. Block 10e (Total Service for Retired Pay) reflects 9 years, 9 months, and 8 days.

On 19 July 2012, according to Special Order discharged, dated 6 September 2012, the applicant was relieved from assignment and honorably discharged from the ANG and as a member of the Reserve of the Air Force.

# AIR FORCE EVALUATION

ARPC/DPTSP recommends denying the application. Per AFMAN 36-2136, *Reserve Personnel Participation*, chapter 2, 2.2, "...Points may only be credited to the date a Reservist actually performed the duty." ARPC/DPTSP was able to verify the applicant began service on 12 October 2001 and served continuously through 19 July 2012, which was the date of discharge. At the time of discharge, the applicant's point history, reflected 10 years, 9 months, and 8 days of service and 9 years of satisfactory service towards retirement. ARPC/DPTSP found the applicant's records reflect an unsatisfactory year from 12 October 2005 to 11 October 2006 and did not include the partial year of service from 12 October 2011 to 19 July 2012. Additionally, the applicant's record shows a civilian break from 20 July 2012 to 29 November 2021 and does not include the Army Reserve time the applicant states was served from 2015 to 2021. No source documentation for this missing time was received.

Based on the documentation provided by the applicant and analysis of the facts, there is no evidence of an error or injustice. Block 10(e) of the NGB Form 22 is reflecting the correct total service for retired pay of 9 years, 9 months, and 8 days. There is no source documentation for additional points other than what is currently reflected in his record and therefore cannot be awarded with this request. ARPC/DPTSP can update the applicant's record if source documentation is received.

## APPLICANT'S REVIEW OF AIR FORCE EVALUATION

The Board sent a copy of the advisory opinion to the applicant on 12 April 2023 for comment (Exhibit D) but has received no response.

#### FINDINGS AND CONCLUSION


- 1. The application was timely filed.
- 2. The applicant exhausted all available non-judicial relief before applying to the Board.
- 3. After reviewing all Exhibits, the Board concludes the applicant is not the victim of an error or injustice. The Board concurs with the rationale and recommendation of ARPC/DPTSP and finds a preponderance of the evidence does not substantiate the applicant's contentions. Should the applicant provide supporting documentation, such as signed certified orders, AF Form 40a (Record of Individual Inactive Duty Training), Leave and Earnings Statements, DD Forms 214, final point summaries, etc., the Board would be willing to reconsider his request. Therefore, aside from the administrative correction, the Board recommends against correcting the applicant's records.

### RECOMMENDATION

The Board recommends informing the applicant the evidence did not demonstrate material error or injustice, and the Board will reconsider the application only upon receipt of relevant evidence not already presented.

## **CERTIFICATION**
