His Term of Enlistment (TOE) be changed to 3 years, 3 months and 1 week with a date of separation (DOS) of 14 August 2024 rather than 3 years and 4 months with a DOS of 6 September 2024.

APPLICANT'S CONTENTIONS

He enlisted in the Air Force under a six-year contract starting 14 August 2018. He signed a new enlistment contract for the Space Force on 7 May 2021. He believes there was an error when calculating his remaining time in service. Further, he was advised that the new contract should fulfill the remainder of his original contract ending 14 August 2018.

The applicant's complete submission is at Exhibit A.

STATEMENT OF FACTS

The applicant is a currently serving United States Space Force (USSF) Specialist Four (E-4).

On 14 August 2018, according to DD Form 214, *Certificate of Release or Discharge from Active Duty*, the applicant entered active duty.

On 6 May 2021, according to DD Form 214, the applicant was honorably discharged in the grade of senior airman. He served 2 years, 8 months and 23 days total active service and credited with 5 months and 22 days of foreign service. His narrative reason for separation reflects "Miscellaneous/General Reasons."

On 7 May 2021, according to DD Form 4, the applicant enlisted in the USSF for a period of 3 years and 4 months in the grade of E-4 creating a new DOS of 6 September 2024.

AIR FORCE EVALUATION

AFPC/DPMLT recommends denying the application. Based on the documentation provided by the applicant and analysis of the facts, there is no evidence of an error or injustice. All documents

state the applicant selected a 3 year and 4 months TOE. Finally, this was an Enlistment, not a Reenlistment, into Space Force. All Enlistments are years and months only.

APPLICANT'S REVIEW OF AIR FORCE EVALUATION

The Board sent a copy of the advisory opinion to the applicant on 31 March 2023 for comment (Exhibit D) but has received no response.

FINDINGS AND CONCLUSION

1. The application was timely filed.
2. The applicant exhausted all available non-judicial relief before applying to the Board.
3. After reviewing all Exhibits, the Board concludes the applicant is not the victim of an error or injustice. The Board concurs with the rationale and recommendation of AFPC/DPMLT and finds a preponderance of the evidence does not substantiate the applicant's contentions. Therefore, the Board recommends against correcting the applicant's records.

RECOMMENDATION

The Board recommends informing the applicant the evidence did not demonstrate material error or injustice, and the Board will reconsider the application only upon receipt of relevant evidence not already presented.
