APPLICANT'S REQUEST

- 1. His officer performance report (OPR) for the period of 11 Nov 21 to 10 Nov 22 be included in his officer selection record (OSR) for the CY22E (P0422E) Major Line of the Air Force (LAF-A) Central Selection Board (CSB).
- 2. He be considered by a special selection board (SSB) for the P0422E CSB.

APPLICANT'S CONTENTIONS

His OPR ending 10 Nov 22 was not uploaded in his personnel records display application (PRDA) until Jan 23. Accordingly, the OPR was not reviewed by the CSB. The OPR is now in his PRDA.

The applicant's complete submission is at Exhibit A.

STATEMENT OF FACTS

The applicant is a currently serving captain (O-3).

The applicant's OPR for the reporting period ending 10 Nov 22 reflects a final signature date (ratee acknowledgment) of 12 Jan 23.

The military personnel data system (MilPDS) reflects the applicant is projected for promotion to the grade of major (O-4), awaiting announcement of his promotion line number.

AFPC/DPMSPP recommends denial. The applicant met and was non-selected for promotion by the P0422E CSB. He is not entitled to SSB consideration for the P0422E CSB for the OPR ending 10 Nov 22. All signatures on the OPR are after the P0422E CSB convening date of 29 Nov 22.

The applicant must work through the evaluation report appeals board (ERAB) to request correction of the signature dates. All signatures (rater, additional rater, reviewer and ratee) must reflect a date between 10 Nov 22 (close out of the OPR) and 29 Nov 22 (CSB convening date). The SSB request should be submitted within the ERAB case. The case will be forwarded to AFPC Officer Promotions for SSB processing upon correction of the OPR.

The complete advisory opinion is at Exhibit C.

APPLICANT'S REVIEW OF AIR FORCE EVALUATION

The Board sent a copy of the advisory opinion to the applicant on 20 Sep 23 for comment (Exhibit D) but has received no response.

FINDINGS AND CONCLUSION

- 1. The application was timely filed.
- 2. The applicant did not exhaust all available non-judicial relief before applying to the Board.
- 3. After reviewing all Exhibits, the Board concludes the applicant is not the victim of an error or injustice. The Board concurs with the rationale and recommendation of AFPC/DPMSP and finds a preponderance of the evidence does not substantiate the applicant's contentions. In this respect the applicant requests he be considered by a SSB for the P0422E CSB and the SSB review his OPR ending 10 Nov 22. While the OPR closed out prior to the CSB convening date of 29 Nov 22, all signatures were after the convening date. Accordingly, the 10 Nov 22 OPR is not eligible for review by the P0422E CSB. However, the applicant may submit an ERAB application for correction of the dates. Should the ERAB grant his request, AFPC/DPMSP will schedule the applicant for an SSB. Should the ERAB deny the applicant's request, the applicant may request his case be reconsidered by the Board. Therefore, the Board recommends against correcting the applicant's records.
- 4. The applicant has not shown a personal appearance, with or without counsel, would materially add to the Board's understanding of the issues involved.

RECOMMENDATION

The Board recommends informing the applicant other avenues of administrative relief remain available, and the Board will reconsider the application only upon receipt of documentary evidence that such relief has been exhausted.
