His order for the period 5 May 2013 through 14 June 2014 be amended to reflect 10 USC 12301(D).

APPLICANT'S CONTENTIONS

His orders were incorrectly issued under Title 32, and do not count as qualifying service towards the Post 9/11 GI Bill. In accordance with the DAFI 36-2001, Management of Training and Operational Support within the Air National Guard, dated 19 October 2009, paragraph 5.3.5 – all Air National Guard (ANG) members attending undergraduate pilot training programs will attend in a Title 10 status.

STATEMENT OF FACTS

The applicant is a currently serving ANG major (O-4).

Order Number Work-Product, dated 3 April 2014, reflects Type of Duty/Authority: School Military Status (Title 32) 32 USC 504, 505 and ANGI 36-2001. Purpose: Attendance of Formal Training School – Course Name/Number: Joint Primary Pilot Training and Joint Specialized Pilot Training; Itinerary: 5 May 2013 through 7 June 2014.

AIR FORCE EVALUATION

NGB/A1D recommends granting the application. Based on the documentation provided by the applicant and analysis of the facts, there is evidence of an error or injustice. The applicant provided order number Work-Product which covered the period of 5 May 2013 through 14 June 2014 and was issued to attend Joint Primary Pilot Training and Joint Specialized Pilot Training. The FY13 Workday Guidance states, "Traditional members and technicians attending Undergraduate Flying Training (UFT) programs and Developmental Education (DE) programs designated as professional military education credit-awarding in AFI 36-2301, Developmental Education and those formal training courses listed on the Air Force Reserve Orders Writing System (AROWS) Title 10 table will attend in a Title 10 status.

Based on the documentation provided by the applicant and analysis of the facts, there is evidence of an error for order number Work-Product as it was issued incorrectly as Title 32 instead of Title 10

**APPLICANT’S REVIEW OF AIR FORCE EVALUATION**

The Board sent a copy of the advisory opinion to the applicant on 20 November 2023 for comment (Exhibit D) but has received no response.

**FINDINGS AND CONCLUSION**

1. The application was timely filed.
2. The applicant exhausted all available non-judicial relief before applying to the Board.
3. After reviewing all Exhibits, the Board concludes the applicant is the victim of an error or injustice. The Board concurs with the rationale and recommendation of NGB/A1D and finds a preponderance of the evidence substantiates the applicant’s contentions. Therefore, the Board recommends correcting the applicant’s records as indicated below.

**RECOMMENDATION**

The pertinent military records of the Department of the Air Force relating to APPLICANT be corrected to show Order Number *Work-Product*, dated 3 April 2014, for the period 5 May 2013 through 14 June 2014 was issued under Title 10 USC 12301(d).
