SUMMARY OF CASE

The applicant requests she be eligible to receive Continuation Pay (CP) under the Blended Retirement System (BRS).

The applicant’s complete submission is at Exhibit A.

NGB/A1P evaluated the applicant’s request and provided an advisory opinion to the Board recommending the application be approved (Exhibit C). NGB/A1P states the applicant provided a letter from her Force Support Squadron confirming that she was not properly notified of her eligibility to apply for BRS-CP prior to her 12-year anniversary date. The applicant met 12 years of service on 6 Jul 22 and had the Applicant been notified according to the prescribed timeline, all eligibility requirements to receive the BRS CP benefit would have been met.

The advisory opinion(s) were forwarded to the applicant for review and response (Exhibit D and F). As of this date, this office has received no response.

FINDINGS AND RECOMMENDATION

After reviewing all Exhibits, the Board concludes the applicant is the victim of an error or injustice. The Board concurs with the rationale and recommendation of NGB/A1P and finds a preponderance of the evidence substantiates the applicant’s contentions. Therefore, the Board recommends correcting the applicant’s records as indicated below.

The pertinent military records of the Department of the Air Force relating to APPLICANT be corrected to show on 6 July 2022, the applicant submitted a timely and effective Continuation Pay Statement of Understanding and Election to accept Continuation Pay in accordance with Public Law 114-80; her election for Continuation Pay was accepted; and the applicant received a 48-month military service obligation in exchange for the approved Blended Retirement System Continuation Pay election.
