APPLICANT'S REQUEST

His Fiscal Year 2023 (FY23) Tier 3 Aviation Bonus (AvB) Agreement for the period of 1 October 2023 through 30 September 2024 be approved.

APPLICANT'S CONTENTIONS

His FY23 AvB application was timely submitted prior to 31 December 2023. His package was rejected which resulted in his ineligibility for the FY23 AvB. Nevertheless, his documentation was subsequently corrected to reflect accurate information.

STATEMENT OF FACTS

The applicant is an Air National Guard captain (O-3).

AIR FORCE EVALUATION

NGB/A1P recommends granting the application. Based on the documentation provided by the applicant and analysis of the facts, there is evidence of an error or injustice. On 2 November 2023, the applicant and AvB Coordinator digitally signed an FY23 Tier 3 agreement for the period 1 October 2023 through 30 September 2024. On 3 November 2023, the agreement was signed by the Wing Commander. The applicant's case was returned to the AvB coordinator awaiting an update by the base Host Aviation Resource Management office. However, the AvB Coordinator did not submit the corrected documentation until after the program policy end date and the extended submission dates were passed.

APPLICANT'S REVIEW OF AIR FORCE EVALUATION

The Board sent a copy of the advisory opinion to the applicant on 26 August 2024 for comment (Exhibit C) but has received no response.

FINDINGS AND CONCLUSION

1. The application was timely filed.

2. The applicant exhausted all available non-judicial relief before applying to the Board.
3. After reviewing all Exhibits, the Board concludes the applicant is the victim of an error or injustice. The Board concurs with the rationale and recommendation of NGB/AIP and finds a preponderance of the evidence substantiates the applicant's contentions. Therefore, the Board recommends correcting the applicant's records as indicated below.

RECOMMENDATION

The pertinent military records of the Department of the Air Force relating to APPLICANT be corrected to show his Fiscal Year 2023 Tier 3 Aviation Bonus (AvB) Agreement for the period of 1 October 2023 through 30 September 2024, at the rate of \$30,000 per year, was approved.
