APPLICANT'S REQUEST

The date of birth (DOB) on his DD Form 214, *Report of Separation from Active Duty*, be corrected.

APPLICANT'S CONTENTIONS

The DOB on his DD Form 214 is wrong.

The applicant's complete submission is at Exhibit A.

STATEMENT OF FACTS

The applicant is an honorably discharged Air Force sergeant (E-4).

The applicant served in the Air Force from 28 May 71 to 27 May 75, with a DOB recorded differently than the DOB on his DD Form 214.

On 10 Oct 49, the applicant was issued a certified birth certificate, which indicates a different DOB from the DOB on the applicant's DD Form 214.

APPLICABLE AUTHORITY/GUIDANCE

AFI 36-2608, *Military Personnel Records System*, Table A7.5 (Correction to Date of Birth), Note 3, provides as follows: Do not correct records of former members unless evidence proves the date of birth used while serving with the Air Force was erroneously recorded. Required proof is an unaltered original document from the jurisdiction of the applicant's birth, showing the applicant's name and date of birth.

FINDINGS AND CONCLUSION

1. The application was not timely filed, but it is in the interest of justice to excuse the delay.
2. The applicant exhausted all available non-judicial relief before applying to the Board.
3. After reviewing all Exhibits, the Board concludes the applicant is the victim of an error. The Board finds the applicant's date of birth used while serving with the Air Force was erroneously recorded. Therefore, the Board recommends correcting the applicant's records as indicated below.

The pertinent military records of the Department of the Air Force relating to APPLICANT be corrected to show that the DD Form 214, *Report of Separation from Active Duty*, issued in conjunction with the 27 May 75 discharge, be changed to reflect the correct DOB in block 4.
