APPLICANT'S REQUEST

His "Uncharacterized" Entry-Level Separation (ELS) be changed to honorable.

APPLICANT'S CONTENTIONS

His character of service for 24 Jun 04 to 31 Mar 05 be changed to honorable, as he had enlisted and was awaiting officer training school as part of a technical degree sponsorship program ran by Air Force recruiting. He enlisted in Jun 04 through the recruiting program, started officer training school in Jan 05, and graduated and commissioned on 1 Apr 05. From then he served continuously until 26 Aug 12 and received an honorable discharge at separation. In Jan 13, he became a general schedule (GS) employee and followed necessary processes to start and complete a military deposit for all previous active-duty time. In 2023 and 2024, he queried Air Force Personnel Center (AFPC) to acquire a better understanding of his GS retirement, and they informed him his 23 Jun 04 to 31 Mar 05 enlistment was not creditable toward GS retirement, as the DD Form 214, *Certificate of Release or Discharge from Active Duty*, did not list the discharge as honorable; it indicates uncharacterized. Due to this status, they further indicated his following honorable service from 1 Apr 05 to 26 Aug 12 was also not eligible to be applied toward GS retirement, and he should not have been allowed to do a military deposit for any of his service. If uncorrected, his GS retirement will be reduced by eight years.

In support of his request for a discharge upgrade, the applicant provides his DD Form 214s, a memo from Defense Finance and Accounting Service (DFAS), and email traffic regarding civilian retirement.

The applicant's complete submission is at Exhibit A.

STATEMENT OF FACTS

The applicant is a currently serving Air Force Reserve (AFR) lieutenant colonel (O-5).

On 31 Mar 05, the applicant received an ELS. His narrative reason for separation was “Commissioned or Warrant in the Same Branch of Service” and he was credited with nine months and nine days of total active service.

On 26 Aug 12, the applicant resigned and received an honorable discharge. His narrative reason for separation is “Completion of Required Active Service” and he was credited with 7 years, 4 months, and 26 days of total active service.

APPLICABLE AUTHORITY/GUIDANCE

DoDI 1332.14, Enlisted Administrative Separations, incorporating changes through 23 Jun 22 reads as follows:

Enclosure 3, section 2 – Selected Changes in Service Obligation

Paragraph a(3) states an enlisted Service member may be separated due to an acceptance of an active duty commission or appointment, or acceptance into a program leading to such commission or appointment in any branch of Military Service.

Paragraph b(1) states the characterization or description is honorable, unless the separation is an entry-level separation and is required in accordance with section 3 of Enclosure 4.

Enclosure 4, section 3 – Characterization of Service or Description of Separation

Paragraph c(1)(a)2 states an uncharacterized separation will be described as an entry-level if separation is initiated while an enlisted Service member is in entry-level status, except when the Secretary concerned, on a case-by-case basis, determined that characterization of service as honorable is clearly warranted by the presence of unusual military duty. The characterization is authorized when the Service member is separated under Enclosure 3 by reason of selected changes in service obligation.

AFI 36-3208, *Separating Administrative Separation of Airmen*, dated 9 Jul 04, describes the authorized service characterizations that were applicable at the time of the applicant’s separation.

Entry Level Separation. Airmen are in entry level status during the first 180 days of continuous active military service or the first 180 days of continuous active military service after a break of more than 92 days of active service. Determine the member's status by the date of notification; thus, if the member is in entry level status when initiating the separation action, describe it as an entry level separation unless:

A service characterization of under other than honorable conditions is authorized under the reason for discharge and is warranted by the circumstances of the case; or

The Secretary of the Air Force determines, on a case-by-case basis, that characterization as honorable is clearly warranted by unusual circumstances of personal conduct and performance of military duty. This characterization is authorized if reason for separation is a change in military status according to chapter 2 which states the service of airmen separated for completion of officer training will be characterized as honorable.

Honorable. The quality of the airman's service generally has met Air Force standards of acceptable conduct and performance of duty or when a member's service is otherwise so meritorious that any other characterization would be inappropriate.

AIR FORCE EVALUATION

AFPC/DPMSSR recommends granting the application. For many years, officer training school (OTS) operated under their own internal policy with regards to characterizing the service of their graduates. Discussions with them have indicated their policy has shifted from time to time through the years, with some periods in the 1970s being characterized and some periods in the 1980s, 1990s, and 2000s listed as uncharacterized. OTS has been allowed to make the determination since they prepare DD Form 214s on all of their OTS students. Individuals attending OTS are in an active-duty status and therefore, fall under active-duty personnel policy. AFPC has reviewed the current Department of the Air Force Instruction (DAFI) 36-3211, *Military Separations*, and former enlisted separations Air Force Instruction (AFI) 36-3208, and they both offer flexibility to give OTS graduates an honorable service characterization even though they are in entry level status.

APPLICANT'S REVIEW OF AIR FORCE EVALUATION

The Board sent a copy of the advisory opinion to the applicant on 24 Jan 25 for comment (Exhibit D) but has received no response.

FINDINGS AND CONCLUSION

1. The application was not timely filed; however, it is in the interest of justice to excuse the delay.
2. The applicant exhausted all available non-judicial relief before applying to the Board.
3. After reviewing all Exhibits, the Board concludes the applicant is the victim of an error or injustice. The Board concurs with the rationale and recommendation of AFPC/DPMSSR and finds a preponderance of the evidence substantiates the applicant's contentions. The Board notes service members attending OTS have no break in service between their enlisted time at OTS and their

commission date on active duty; therefore, their time spent at OTS qualifies as a change in service obligation and is characterized as honorable service. Therefore, the Board recommends correcting the applicant's records as indicated below.

4. The applicant has not shown a personal appearance, with or without counsel, would materially add to the Board's understanding of the issues involved.

RECOMMENDATION

The pertinent military records of the Department of the Air Force relating to APPLICANT be corrected to show on 31 Mar 05, he was discharged with service characterized as honorable.
