## SUMMARY OF CASE

The applicant requests he be eligible to receive Continuation Pay (CP) under the Blended Retirement System (BRS).

The applicant's complete submission is at Exhibit A.

AFPC/DPMSSM evaluated the applicant's request and provided an advisory opinion to the Board recommending the application be approved (Exhibit C). AFPC/DPMSSM states although the applicant did not sign his BRS-CP Statement of Understanding (SOU) on or before their 12-year pay date anniversary, the myFSS system did not send out the initial notification and failed to send out additional notifications every month until the applicant's 12-year pay date anniversary. The applicant reached 12 years of service on 17 Jan 24 and was otherwise eligible for BRS CP.

The advisory opinion(s) were forwarded to the applicant for review and response (Exhibit D). As of this date, this office has received no response.

## FINDINGS AND RECOMMENDATION

After reviewing all Exhibits, the Board concludes the applicant is the victim of an error or injustice. The Board concurs with the rationale and recommendation of AFPC/DPMSSM and finds a preponderance of the evidence substantiates the applicant's contentions. Therefore, the Board recommends correcting the applicant's records as indicated below.

The pertinent military records of the Department of the Air Force relating to APPLICANT be corrected to show on 17 January 2024, the applicant submitted a timely and effective Continuation Pay Statement of Understanding and Election to accept Continuation Pay in accordance with Public Law 114-80; his election for Continuation Pay was accepted; and the applicant received a 48-month military service obligation in exchange for the approved Blended Retirement System Continuation Pay election.

The applicant has not shown a personal appearance, with or without counsel, would materially add to the Board's understanding of the issues involved.
