APPLICANT'S REQUEST

His career data brief and point credit accounting and reporting summary (PCARS) reflect he was promoted to staff sergeant (E-5) from 1 Jan 13 to 25 Oct 15.

APPLICANT'S CONTENTIONS

He noticed the error in spring 2023, after reviewing his records to understand when his promotion cycle for major (O-4) would become available. He is still in the Air Force Reserve (AFR). The Board should consider this even though he is outside of the three-year window because he continues to serve, and updated/accurate records are important. On 3 Aug 12, he was notified of promotion to E-5. He was selected for palace chase later in the year 2012. His last day on active duty was 31 Dec 12 and the first day in the AFR was 1 Jan 13. His career data brief did not include his updated grade of E-5. The correction should be made because he remained in the AFR until 30 Aug 14. Soon after, he entered the Obligated Reserve to accept a commission and return to active-duty as a second lieutenant (O-1) on 3 Aug 16. He tried to resolve the issue through the Total Force Service Center (TFSC) and the AFBCMR through MyVector, but both were unable to resolve the issue.

STATEMENT OF FACTS

The applicant is a currently serving Air Force captain (O-3).

On 3 Aug 12, a weighted airman promotion system (WAPS) score notice, provided by the applicant, indicates he was selected for promotion during the 12E5 cycle, with a line number of

On 31 Dec 12, the DD Form 214, *Certificate of Release or Discharge from Active Duty*, indicates the applicant was honorably discharged with a narrative reason for separation of "Intradepartmental Transfer," and he was credited with three years, six months, and two days of total active service. His grade at discharge is senior airman (E-4).

AIR FORCE EVALUATION

AFPC/DPMSPS recommends denying the application, finding no evidence of an error or injustice with his promotion. The applicant was initially selected for promotion to staff sergeant (E-5) during the 12E5 cycle, with a line number of [Work-Pro...]. The incrementing date of this line number would have been 1 Aug 13. The applicant would have had to be serving on active duty, and completed professional military education (PME) before the promotion line number would have incremented on 1 Aug 13. After a review of the evidence provided by the applicant and official documentation in his military record, AFPC/DPMSPS was able to verify the applicant separated from the Air Force before his line number ([Work-Pro...]) incremented. Furthermore, there is no evidence the applicant completed the requirements for promotion before separating on 31 Dec 12.

APPLICANT'S REVIEW OF AIR FORCE EVALUATION

The Board sent a copy of the advisory opinion to the applicant on 2 Apr 25 for comment (Exhibit D) but has received no response.

FINDINGS AND CONCLUSION

1. The application was timely filed.
2. The applicant exhausted all available non-judicial relief before applying to the Board.
3. After reviewing all Exhibits, the Board concludes the applicant is not the victim of an error or injustice. The Board concurs with the rationale and recommendation of AFPC/DPMSPS and finds a preponderance of the evidence does not substantiate the applicant's contentions. Therefore, the Board recommends against correcting the applicant's records.
4. The applicant has not shown a personal appearance, with or without counsel, would materially add to the Board's understanding of the issues involved.

RECOMMENDATION

The Board recommends informing the applicant the evidence did not demonstrate material error or injustice, and the Board will reconsider the application only upon receipt of relevant evidence not already presented.
