SUMMARY OF CASE

The applicant requests he receive a special board (SB) for promotion consideration to lieutenant colonel (O-5) for the CY24 Air Force Reserve (AFR) Lieutenant Colonel Line and Nonline Position Vacancy (PV) Promotion Selection Board.

The applicant's complete submission is at Exhibit A.

ARPC/PB evaluated the applicant's request and provided an advisory opinion to the Board recommending the application be approved (Exhibit C). ARPC/PB states that the supporting documentation provided by the applicant confirms that through no fault of the applicant, his servicing organization failed to submit his PV Promotion Recommendation Form (PRF) to ARPC 45 days prior to the promotion board convene date (5 Jul 24). The PRF was signed by the senior rater and the administrative oversight is an error or injustice to the applicant.

The advisory opinion(s) were forwarded to the applicant for review and response (Exhibit D). As of this date, this office has received no response.

FINDINGS AND RECOMMENDATION

After reviewing all Exhibits, the Board concludes the applicant is the victim of an error or injustice. The Board concurs with the rationale and recommendation of ARPC/PB and finds a preponderance of the evidence substantiates the applicant's contentions. Therefore, the Board recommends correcting the applicant's records as indicated below.

The pertinent military records of the Department of the Air Force relating to APPLICANT be corrected to show he be provided supplemental promotion consideration for the Calendar Year (CY) 2024 United States Air Force Reserve (USAFR) Line and Nonline Lieutenant Colonel Position Vacancy (PV) Promotion Selection Board.
