

**SUMMARY:** The Applicant was discharged on August 10, 2012 in accordance with Air Force Instruction 36-3208, *Administrative Separation of Airmen*, with an Under Honorable Conditions (General) Service Characterization for Alcohol Rehabilitation Failure. The Applicant appealed for an upgrade of their Service Characterization and a change to the Narrative Reason for separation.

The Applicant requested the Board be completed based on a Record Review. The Board was conducted on November 24, 2025. The Applicant was not represented by counsel.

The attached examiner's brief (provided to applicant only), extracted from available service records, contains pertinent data regarding the circumstances and character of the Applicant's military service.

**DISCUSSION:** The Discharge Review Board (DRB), under its responsibility to examine the propriety and equity of an Applicant's discharge, is authorized to change the Characterization of Service and the Narrative Reason for discharge if such changes are warranted. If applicable, the Board can also change the Applicant's Reentry Code. In reviewing discharges, the Board presumes regularity in the conduct of governmental affairs unless there is substantial credible evidence to rebut the presumption, to include evidence submitted by the Applicant. The Board completed a thorough review of the circumstances that led to the discharge and the discharge process to determine if the discharge met the pertinent standards of equity and propriety.

The Applicant's record of service included the following documented misconduct leading up to their discharge:

- Letter of Reprimand for failing to show for PT
- Letter of Reprimand for disregarding tech manual resulting in damage to a propeller dome shell
- Letter of Counseling for failing to show up for work on time
- Letter of Counseling for disrespect to an NCO

The documentary evidence the Board considered as part of the review includes, but is not limited to the DD Form 293, *Application for the Review of Discharge from the Armed Forces of the United States*, and any additional documentation submitted by Applicant and/or counsel; the Applicant's personnel file from the Automated Records Management System (ARMS); and the DRB Brief detailing the Applicant's service information and a summary of the case.

The Applicant requested that their discharge characterization be upgraded from General to Honorable and that the remark "Member has not completed first full term of service," in Section 18 of their DD Fm 214 be removed. In support of the upgrade the Applicant provided their reenlistment documents from 2011.

The DRB determined the discharge was proper and equitable. An administrative review of the Applicant's records revealed a pattern of misconduct throughout their military service, beginning with their disenrollment from the USAFA, which led to an obligation to serve two years of enlisted active duty. In August 2011, the Applicant self-referred to ADAPT following an alcohol-related incident but was deemed a program failure. This incident, coupled with the prior adverse actions, formed the basis for the discharge. Furthermore, the Applicant failed to provide substantial documentation to justify an upgrade. Therefore, the Board denied the Applicant's appeal for an upgrade of their Service Characterization and a change to the Narrative Reason for separation.

Additionally, the Board considered the factors laid out in the attachment to the Under Secretary of Defense memorandum, *Guidance to Military Discharge Review Boards and Boards for Correction of Military/Naval Records Regarding Equity, Injustice, or Clemency Determinations*, dated 25 June 2018, known as the "Wilkie

Memo.” The Board considered the factors listed in paragraphs (6)(a)-(6)(l) and (7)(a)-(7)(r) of this memorandum and found no evidence of inequity or impropriety.

**FINDING AND CONCLUSION:** After a thorough review of the available evidence, to include the Applicant’s issues, summary of service, service/medical record entries, and discharge process, the Board found the discharge was proper and equitable. The DRB voted unanimously to *deny* the Applicant’s request. Therefore, the awarded Service Characterization shall remain “Under Honorable Conditions (General),” the Narrative Reason for separation shall remain Alcohol Rehabilitation Failure, and the Reentry Code shall remain 2B. The DRB results were approved by the Presiding Officer on December 4, 2025.

Should the Applicant wish to appeal this decision, the Applicant must request a personal appearance before this Board before applying for relief to the Air Force Board for Correction of Military Records (AFBCMR). In accordance with DAFI 36-2603, *Air Force Board for Correction of Military Records*, all Applicants before the AFBCMR must first exhaust available administrative avenues of relief before applying to the AFBCMR, otherwise their AFBCMR case will be administratively closed until such time that the Applicant avails themselves of the available avenue of relief. Therefore, should the Applicant wish to appeal this decision, they must first exercise their right to make a personal appearance before the AFDRB.
