FACTS:

- 1. Incorporated herein by reference are military records which were summarized in the previous consideration of the applicant's case by the Army Board for Correction of Military Records (ABCMR) in Docket Number AR20190006071 on 14 November 2019.
- 2. The applicant states that his previously submitted request should be further evaluated based upon the provisions set forth in Title 10, United States Code, section 12738 and Section 12731. He contests that he was ill advised at the time of his transfer

into the Retired Reserve noting that Orders Number 319-001 reflects the statement "Early Retired Pay at Age 60 (Involuntary) Medical Disqualification Member (15-years of service (XM))." The Human Resource Officer, Massachusetts ARNG provides that the correct code should have been "MG" since the applicant did not have 15-years of qualifying service

- 3. A review of the applicant's available service records reflects the following:
- a. After previously serving in the U.S. Marine Corps for 1 month 28 days, on 30 September 1993, the applicant enlisted in the ARNG for 8 years.
 - b. On 19 May 1996, the applicant extended his current enlistment by 1 year.
 - c. On 12 July 1997, the applicant extended his current enlistment by 1 year.
 - d. On 25 July 1998, the applicant extended his current enlistment by 3 years.
 - e. On 16 September 2001, the applicant extended his current enlistment by 1 year.
- f. On 27 November 2002, the ARNG issued Orders Number 331-16, honorably discharging the applicant from the ARNG, effective 3 October 2002. NGB Form 22, item 10a. (Net Service this Period) reflects "9 years and 4 days."
 - g. On 19 October 2007, the applicant enlisted in the ARNG for 1 year.
 - h. On 12 September 2008, the applicant extended his current enlistment by 6 years.
- i. On 15 November 2013, the ARNG issued Orders Number 319-001, honorably discharging the applicant from the ARNG and transferring him into the Retired Reserve, effective 20 July 2013. The additional instructions provide "Early Retirement Pay at Age 60 (Involuntary) Medical Disqualified Member (15+ Years of Service) (XM)"; Authority; National Guard Regulation (NGR) 600-200, Paragraph 6-35(I)(8).
- j. On 20 July 2013, the applicant was transferred into the Retired Reserve. NGB Form 22:
 - item 10a. (Net Service this Period) reflects "5 years, 9 months, and 2 days"
 - item 10b. (Prior Reserve Component Service) reflects "8 years, 8 months, and 22 days"
 - item 10c. (Prior Active Federal Service) reflects "5 months and 10 days"
 - item 10e (Total Service for Retired Pay) reflects "14 years, 3 months, and 24 days"

k. On 26 July 2022, AHRC advised the applicant, in response to his application for retired pay benefits, that an audit of his military records reflects that he completed 14 years, 3 months, and 24 days of qualifying service for retirement. Therefore, the applicant was ineligible for retired pay.

- fff. Medical documents reflective of applicant's health concerns as provided to the VA or other agencies/boards as applicable.
- ggg. Memorandum Subject: Findings and Recommendation of the SMRB, reflective of the applicant being advised that after review of his submitted medical documentation he was determined to be unfit for continued military service. Therefore, the applicant was recommended for separation with an effective date of 20 July 2013.
- hhh. Memorandum Subject: Commanders Performance and Recommendation, dated 13 June 2013, reflective of the applicant's commander's concurrence with the recommendation for medical separation made by the State Medical Review Board. The commander noted that the applicant currently has an expiration term service date of 18 October 2014 and has completed 15 or more years of service creditable for retirement.

- iii. Memorandum Subject: Victim of Sexual Assault Statement for Medical Separation, dated 14 June 2013, reflective of the applicant's denial of filing an unrestricted report pertaining to sexual assault within the past 24 months.
- jjj. Memorandum Subject: State Medical Review Board Recommendation Waiver of Right to Appeal, dated 14 June 2013, reflective of the applicant's waiver of his rights to appeal the recommendation made by the State Medical Review Board.
- kkk. Memorandum Subject: Review and Recommendation for Separation, dated 20 July 2013, reflective of the ARNG, G-1, concurrence with the recommendation that the applicant be medically separated, effective 20 July 2013.
- III. Memorandum Subject: Medical Evaluation Board (MEB) Counseling, dated 18 July 2013, reflective of the applicant being counseled on his rights associated with being considered by a MEB. The applicant expressed that he did not want to continue with the MEB process. He further provided that he had already completed 15 years of creditable service and would like to continue with his separation in accordance with NGR 600-200, chapter 6-35 (I)(8).

mmm. AHRC letter, dated 22 October 2018, reflective of the applicant's retirement application being returned due to missing information and or missing documents. The applicant was advised that he had only completed 14 years, 3 months, and 24 days of creditable service towards retirement.

- nnn. Information paper Notification of Eligibility for Retired Pay at Age 60 15 Year letter reflective of information pertaining to the requirements that must be met in order to be eligible for receipt of retired pay at age 60 based upon the completion of 15 years of creditable service.
- ooo. ARNG Information Guide on Non-Regular Retirement reflective of information pertaining to the eligibility criteria for entitlement to retired pay at age 60. The applicant highlights the information pertaining to the 15-year requirement wherein it provides that a servicemember must have "served at least 15 years but less than 20 years of qualifying service and meet all other eligibility criteria." The applicant further provides that under Title 10, USC, section 12738, that "after a person is granted retired pay under this chapter, or is notified in accordance with section 12731(d) that the person has completed the years of service required for eligibility for retired pay under this chapter, the persons eligibility for retired pay may not be denied or revoked in the basis of any error, miscalculation, misinformation or administrative determination of years of service unless it is resulted directly from fraud or misrepresentation of the person. Importantly, in the aforementioned citation, this refers to a current or former Soldier who "has performed at least 20 years of service computed under section 12732. It does not protect the person to whom an erroneous notification of eligibility for retired pay for non-

regular service was issued when the last 6 or last 8 years rule was not computed correctly. That requirement is stated in section 12731(a)(3) as "in the case of a person who completed the service requirements before 25 April 2005, performed the last six years of qualifying service while a member of the Army Reserve,

5. On 14 November 2019, ABCMR Docket Number AR20190006071 the Board considered the applicant's request, supporting documents and evidence in the records. The Board considered the applicant's statement, his record of service, the results of the State Medical Review Board, the applicant's waiving his right to appeal and his declination of an MEB, orders assigning him to the Retired Reserve and his Army National Guard Retirement Points History showing 14 years, 3 months, and 24 days of creditable service for retirement pay. The Board found no evidence of error in the applicant's service calculations and the applicant provided none. Based on a preponderance of evidence, the Board determined that the applicant did not have the requisite service to qualify him for receipt of a notification of eligibility for retired pay at age 60.

BOARD DISCUSSION:


- 1. After reviewing the application, all supporting documents, and the evidence found within the military record, the Board found relief is not warranted.
- 2. The requirements to be eligible for non-regular retired pay at age 60 are set in law. In this case, the applicant did not complete the 15 years of qualifying service to be eligible for retired pay at age 60. The Board determined the evidence does not provide a basis for correction of the record to show the applicant met the statutory requirement to be eligible for retired pay at age 60 based on 15 years of qualifying service.

BOARD DETERMINATION/RECOMMENDATION:

REFERENCES:

- 1. Title 10, USC, section 12732 (Entitlement to Retired Pay) provides for the purpose of determining whether a person is entitled to retired pay under section 12731 of this title, the person's years of service are computed by adding the following:
 - 1 point for each day of active service or full-time service while performing annual training duty or while attending a prescribed course of instruction or if that service conformed to required standards and qualifications
 - 1 point for each attendance at drill or period of equivalent instruction
 - 15 per year of membership
- 2. Title 10, USC Section 12731b (Special Rule for Members with Physical Disabilities not Incurred in the Line of Duty) provides that in the case of a member of the Selected Reserve of a reserve component who no longer meets the qualifications for membership in the Selected Reserve solely because the member is unfit because of physical disability, the Secretary concerned may, for purposes of section 12731 of this title, determine to treat the member as having met the service requirements of subsection (a)(2) of that section and provide the member with the notification required by subsection (d) of that section if the member has completed at least 15, and less than 20, years of service computed under section 12732 of this title.
- 3. NGR 600-200 (Enlisted Personnel Management), chapter 6-35(I)(8) provides that commanders, who suspect that a Soldier may not be medically qualified for retention, will direct the Soldier to report for a complete medical examination per AR 40-501

(Standards of Medical Fitness). Commanders who do not recommend retention will request the Soldier's discharge.

- 4. Army Regulation 135-180 (Qualifying Service for Retired Pay Non-Regular Service), Section II (Notification Requirement) provides the following: under Title 10, USC, section 12731b. Reserve Component Soldiers who complete the eligibility requirements in section I (15-years of qualifying service, and less than 20, computed under Title 10, USC, section 12732, if the individual is to be separated because the Soldier has been determined unfit for continued Selected Reserve service will be notified in writing within 1 year after completion of the required service in accordance with AR 140–185 or NGR 680–2.
- a. Paragraph 2-1, to be eligible for retired pay, an individual need not have a military status at the time of application, but must have:
 - attained age 60
 - a minimum of 20 years of qualifying service computed under Title 10, USC, section 12732; or;
 - 15 years of qualifying service, and less than 20, computed under Title 10, USC, section 12732, if the individual is to be separated because the Soldier has been determined unfit for continued Selected Reserve service
- b. Paragraph 2-4b. (Notification of Eligibility for retired Pay at Age 60 (20 Year letter) provides that after a Soldier has been notified of their eligibility for retired pay for non-regular service, the Soldier's eligibility for retired pay may not be denied or revoked on the basis of any error, miscalculation, misinformation, or administrative determination of years of service performed, unless it resulted directly from the fraud or misrepresentation of the individual concerned. However, the number of years of creditable service upon which retired pay is computed may be adjusted to correct any error, miscalculation, misinformation, or administrative determination, and when such a correction is made, the person is entitled to retired pay in accordance with the number of years of creditable service, as corrected, from the date they are granted retired pay
- c. Paragraph 2-5 (Notification of Eligibility for Retired Pay (15 year letter), provides under Title 10, USC, section 12731b, RC Soldiers in an active status who are covered by paragraph 2–2b and have at least 15, and fewer than 20 years of qualifying service, will be issued the Notification of Eligibility for Retired Pay (15 Year Letter). Paragraphs 2–4b through 2–4d apply to the Notification of Eligibility for Retired Pay (15 Year Letter).
- 5. Title 10, USC, section 1552 states, the Secretary concerned may pay, from applicable current appropriations, a claim for the loss of pay, allowances, compensation, emoluments, or other pecuniary benefits, or for the repayment of a fine or forfeiture, if,

as a result of correcting a record under this section, the amount is found to be due the claimant on account of his or another's service in the Army.
