<u>APPLICANT REQUESTS:</u> in effect, correction of his DD Form 214 (Certificate of Release or Discharge from Active Duty), ending on 31 March 1996, to reflect he was awarded the Armed Forces Expeditionary Medal.

<u>APPLICANT'S SUPPORTING DOCUMENT(S) CONSIDERED BY THE BOARD:</u>
DD Form 149 (Application for Correction of Military Record).

FACTS:

- 1. The applicant did not file within the 3-year time frame provided in Title 10, U.S. Code (USC), section 1552(b); however, the Army Board for Correction of Military Records (ABCMR) conducted a substantive review of this case and determined it is in the interest of justice to excuse the applicant's failure to timely file.
- 2. The applicant states in effect, he requests the correction of his DD Form 214 to reflect he was awarded the Armed Forces Expeditionary medal for his service during Uphold Democracy during the period of 16 September 1994 through 31 March 1995. The Armed Forces Expeditionary Medal was awarded but after he retired. During this period, he was also awarded the Joint Services Medal.
- 3. A review of the applicant's service record shows:
- a. On 27 November 1973, the applicant enlisted in the Regular Army (RA). Block 49 (Prior Service) of the DD Form 4 (Enlistment Contract Armed Forces of the United States) shows the applicant's prior service was in the USAR and he had no active Federal service.
- b. On 26 October 1977, the applicant was honorably released from active duty and assigned to the USAR Control Group (Reinforcement). DD Form 214 (Report of Separation from Active Duty) shows the applicant completed 4-years and 27-days of active service.

- c. On 28 August 1979, Orders Number 08-1052907, issued by the Office of the Adjutant General Reserve Components Personnel and Administration Center, the applicant was honorably discharged from the USAR, effective 28 September 1979.
- d. On 6 December 1982, the applicant enlisted in the USAR and on 19 April 1983, the applicant was discharged from the USAR to accept an enlistment in the RA.
- e. On 19 April 1983, Orders Number 82-11, issued by the Military Entrance Processing Station, the applicant was ordered to active duty for a 3-year active duty commitment.
- f. On 11 April 1985, the applicant was honorably released from active duty and assigned to the USAR Control Group (Reinforcement), to accept appointment as a commissioned officer. His DD Form 214 shows the applicant completed 1-year, 11-months, and 23-days of active service.
- g. On 12 April 1985, the applicant executed his oath of office and was appointed as a Reserve commissioned officer. He had was ordered to active duty as a 3-year obligated volunteer officer, effective 12 April 1985.
- h. The applicant's DA Form 67-8 (Officer Evaluation Report) for the period of service 1 July 1994 through 30 June 1995 shows the applicant was assigned to Tooele Army Depot, Tooele, UT as a Maintenance Officer. His rater rated his performance as always exceeded the requirements. The rater commented the applicant was commended for his outstanding performance of duty while deployed to Haiti as part of the Combined Joint Task Force.
- i. On 4 December 1995, Orders Number S227-3, issued by the U.S. Total Army Personnel Command, the applicant was retired from active service and assigned to the USAR Control Group (Retired Reserve) and placed on the retired list, effective 1 April 1996.
- j. On 31 March 1996, the applicant was honorably retired for voluntary early retirement. DD Form 214 shows the completed 19-years, 3-months, and 25-days of active service. It also shows in:
 - Item 12a (Date Entered Active Duty This Period): 6 December 1976
 - Item 13 (Decorations, Medals, Badges, Citations and Campaign Ribbons Awarded or Authorized):
 - Meritorious Service Medal (2nd Award)
 - Army Commendation Medal (2nd Award)
 - Joint Service Achievement Medal

- Army Achievement Medal
- Army Superior Unit Award
- Army Good Conduct Medal
- National Defense Service Medal (2nd Award)
- Army Service Medal
- Overseas Service Ribbon 3rd Award
- Air Assault Badge
- q. The applicant's service record evidence of his deployment and redeployment to Haiti.

BOARD DISCUSSION:

After reviewing the application, all supporting documents, and the evidence found within the military record, the Board found that relief was not warranted. The applicant's contentions, the military record, and regulatory guidance were carefully considered. Although the applicant's OER for the period of service 1 July 1994 through 30 June 1995 shows the applicant was assigned to Tooele Army Depot, Tooele, UT as a Maintenance Officer as his rater stated that the applicant was commended for his outstanding performance of duty while deployed to Haiti as part of the Combined Joint Task Force, there is insufficient evidence such as an Leave and Earnings Statement (to show hostile fire pay), award recommendation, deployment orders, temporary change of station order, travel voucher, or other evidence that shows the exact dates of arrival in and departure from Haiti. Therefore, his eligibility for this award cannot be established. If the applicant can provide the exact dates of his deployment with supporting documentary evidence, he may apply to this Board for reconsideration.

REFERENCES:

- 1. Title 10, USC, section 1552(b), provides that applications for correction of military records must be filed within 3 years after discovery of the alleged error or injustice. This provision of law also allows the ABCMR to excuse an applicant's failure to timely file within the 3-year statute of limitations if the ABCMR determines it would be in the interest of justice to do so.
- 2. Army Regulation (AR) 600-8-22 (Military Awards), implements a part of the Army Awards Program. It prescribes Department of the Army (DA) policy, criteria, and procedures for individual and unit military awards and foreign decorations and badges.
- a. Paragraph 2-12 (Armed Forces Expeditionary Medal), may be awarded to service members of the Armed Forces of the United States who:
 - Participate or have participated as members of the U.S. military units in a U.S. military operation in which Servicemembers of any military department participate, in the opinion of the Joint Chiefs of Staff, in significant numbers
 - Encounter during such participation foreign armed opposition, or are otherwise placed, or have been placed, in such position that, in the opinion of the Joint Chiefs of Staff, hostile action by foreign armed forces was imminent even though it did not materialize

The Armed Forces Expeditionary Medal may be authorized for the categories of operations listed below. Specific operations approved by the Department of Defense for award of the Armed Forces Expeditionary Medal are listed in paragraph C-5:

- U.S. military operations
- U.S. operations in direct support of the United Nations (UN)
- U.S. operations of assistance for friendly foreign nations

Servicemembers must have been permanently assigned, attached, or detailed to a unit that participated in or was engaged in direct support of designated operations for 30 consecutive days or for 60 non-consecutive days in the Area of Eligibility (AOE) or meet one of the following criteria, regardless of time spent in the AOE:

- was engaged in actual combat or duty that is equally hazardous as combat duty with armed opposition
- while participating in a designated operation was killed or was wounded or injured requiring medical evacuation from the AOE
- accumulates required days service (consecutive or nonconsecutive) while
 participating as a regularly assigned air crewmember of an aircraft flying sorties
 into, out of, within, or over the area in direct support of the military operation

b. Appendix C (Department of Defense Awards and Decorations Procedures), C-5 (Armed Forces Expeditionary Medal), the Armed Forces Expeditionary Medal may be authorized for the categories of operations listed in tables C-3, C-4, and C-5. Table C-3 (Armed Forces Expeditionary Medal) shows Haiti-Operations Uphold Democracy during the period of 16 September 1994 through 31 March 1995 is authorized for awarding of the Armed Forces Expeditionary Medal.
