APPLICANT REQUESTS: correction of his DA Form 5016 (Retirement Accounting Statement) to add 12 retirement points for Retirement Year Ending (RYE) 12 September 2023.

APPLICANT'S SUPPORTING DOCUMENT(S) CONSIDERED BY THE BOARD:

- DD Form 149 (Application for Correction of Military Record)
- DA Form 1380 (Record of Individual Performance of Reserve Duty Training) dated 7 – 8 January 2023
- DA Form 1380 dated 11 – 12 February 2023
- DA Form 1380 dated 24 – 25 June 2023

FACTS:

1. The applicant states he has three DA Forms 1380 that were never submitted by the Unit Administrator (UA). He says the UA claims that she forgot to submit the forms and since they are over 180 days, the applicant has to submit the forms through this site in order to have his records updated to show he was present during the training dates.

2. A review of the applicant's service record shows:

a. He enlisted in the Regular Army on 23 September 2005 for 3 years and 19 weeks and continued service through reenlistments and extensions.

b. DD Form 214 (Certificate of Release or Discharge from Active Duty) shows in block 12a that the applicant entered active duty this period on 23 September 2005 and was honorably released from the active duty on 10 December 2016 for completion of his required active service. A DD Form 215 (Correction to DD Form 214, Certificate of Release or Discharge from Active Duty) was issued showing in block 5 (Original DD Form 214 is Corrected as Indicated Below) correction to item 9 (Command to Which Transferred).

c. On or about 11 December 2016, the applicant enlisted in the U.S. Army Reserve (USAR) and was assigned to a Troop Program Unit.

d. DA Form 4836 (Oath of Extension of Enlistment or Reenlistment) dated 15 October 2022 shows he completed an extension/reenlistment for a period of 2 years in the USAR.

e. He reenlisted in the USAR on 27 September 2024 for an indefinite period.

f. DA Form 5016 dated 12 October 2023, shows the applicant earned the following points for RYE 12 September 2023; 12 inactive duty training points, 12 membership points, and 10 active duty training points, totaling 34 points creditable.

3. The applicant provides:

a. DA Form 1380 dated 30 June 2023 showing the applicant attended training that included the following events for points only on 7 and 8 January 2023 for 8 hours each day totaling 4 retirement points and the form was endorsed by Captain (CPT) [REDACTED] as the officer having knowledge of the duties performed:

- S1 Due Outs
- Integrated Personnel and Pay System - Army (IPPS-A) Breakout Sessions
- Phishing Awareness v5
- Ammo 67/Hazmat
- Manage Components of Roles I-III
- React to Unexploded Ordinance
- Unit Physical Training (PT)
- Army Private Public Partnership
- Range Planning Meeting
- Land Navigation
- Use Visual Signaling Techniques

b. DA Form 1380 dated 30 June 2023 showing the applicant attended training that included the following events for points only on 11 and 12 February 2023 for 8 hours each day totaling 4 retirement points and the form was endorsed by CPT [REDACTED] as the officer having knowledge of the duties performed:

- S1 Due Outs,
- Equal Opportunity
- Master Resiliency Training (Hunt the Good Stuff)
- Operational Security Awareness
- Provide Oral Hygiene Instruction
- Transport a Casualty and Transport a Casualty Using Military Vehicles
- Unit PT
- Postpartum Care

- Range Planning Meeting
- Recommend Individual an Award
- Pace Count

c. DA Form 1380 dated 30 June 2023 showing the applicant attended training that included the following events for points only on 24 and 25 June 2023 for 8 hours each day totaling 4 retirement points and the form was endorsed by CPT [REDACTED] as the officer having knowledge of the duties performed:

- S1 Due Outs
- Record Army Combat Fitness Test
- Government Travel Credit Card/Defense Travel System Voucher Workshop
- Additional Duty Roster Assignments
- Family Day Planning
- Range Planning
- Annual Training (AT) Mission Prep
- Platoon Time

4. On 26 September 2024, in the processing of this case, the U.S. Army Reserve Command (USARC), Military Services Office, provided an advisory opinion recommending approval. USARC reviewed the applicant's documents and determined he should be awarded 12 retirement points based off Army Regulation (AR) 140-185 (Training and Retirement Point Credits and Unit Level Strength Accounting Records). The applicant's administrator failed to process the action in a timely manner. A favorable decision by (Army Review Boards Agency will correct this issue.

5. On 9 October 2024, the applicant was provided with a copy of the advisory opinion for comment or rebuttal. He did not respond.

BOARD DISCUSSION:

After reviewing the application, all supporting documents, and the evidence found within the military record, the Board found that relief was warranted. The Board carefully considered the applicant's record of service, documents submitted in support of the petition, and executed a comprehensive review based on law, policy, and regulation. The Board reviewed and concurred with the U.S. Army Reserve Command's advising official and determined the evidence supports the applicant submitted his DA Forms 1380 for the retirement year ending (RYE) 12 September 2023, totaling 12 retirement points.

BOARD DETERMINATION/RECOMMENDATION:

The Board determined the evidence presented is sufficient to warrant a recommendation for relief. As a result, the Board recommends that all Department of the Army records of the individual concerned be corrected by awarding the applicant qualifying retirement points on the dates indicated below, provided all other criteria is met:

- 2 retirement points for 7 January 2023
- 2 retirement points for 8 January 2023
- 2 retirement points for 11 February 2023
- 2 retirement points for 12 February 2023
- 2 retirement points for 24 June 2023
- 2 retirement points for 25 June 2023

REFERENCES:

1. AR 140-185 (Training and Retirement Point Credits and Unit Level Strength Accounting Records):

a. Paragraph 2-2 (Criteria for earning retirement points) states retirement points may be earned by U.S. Army Reserve Soldiers for active duty or duty in an active status for active duty for training (ADT), initial active duty for training (IADT), involuntary active duty for training (involuntary ADT), voluntary IDT, annual training (AT), IDT, membership points, and for other activities specified in this regulation.

- Four-hour rule; Soldiers earn one point for each scheduled 4-hour period of IDT at Battle Assembly, Rescheduled Training (RST), Equivalent Training, or Additional Training Assemblies
- Four/eight-hour rule; Soldiers earn one point for each 4 hour or greater period, award of a second point in the same day requires additional hours to bring the day's total to a minimum of 8 hours for a maximum of two points in 1 calendar day

b. Paragraph 3-3 (DA Form 1380) states nonpaid DA Forms 1380 will not be entered into Automated Drill Attendance Reporting Software (ADARS) and will be forwarded to HRC for award of retirement points no later than the end of each duty month.

c. Table 3-1 provides that the code "N" will be entered for RST. The code "N" indicates the Soldier is entitled to retirement point credit only.

2. Department of Defense Instructions 1215.07 (Service Credit for Non-Regular Retirement) states inactive duty may be credited for each attendance at an inactive duty training period. A maximum of 2 retirement points for attendance at inactive duty training periods or equivalent training, in any 1 calendar day. The Service member's participation is without payment other than the pay to which the Service member is entitled as a Reserve Component member. Credit no more than one retirement point for fewer than 8 hours.
