This is in reference to your application for correction of your naval record pursuant to the provisions of title 10 of the United States Code, section 1552.

A three-member panel of the Board for Correction of Naval Records, sitting in executive session, considered your application on 17 August 1999. Your allegations of error and injustice were reviewed in accordance with administrative regulations and procedures applicable to the proceedings of this Board. Documentary material considered by the Board consisted of your application, together with all material submitted in support thereof, your naval record and applicable statutes, regulations and policies. In addition, the Board considered the advisory opinion furnished by BUPERS Memorandum 5420 PERS-4010 of 24 July 1999, a copy of which is attached.

After careful and conscientious consideration of the entire record, the Board found that the evidence submitted was insufficient to establish the existence of probable material error or injustice. In this connection, the Board substantially concurred with the comments contained in the advisory opinion. Accordingly, your application has been denied. The names and votes of the members of the panel will be furnished upon request.

It is regretted that the circumstances of your case are such that favorable action cannot be taken. You are entitled to have the Board reconsider its decision upon submission of new and material evidence or other matter not previously considered by the Board. In this regard, it is important to keep in mind that a presumption of regularity attaches to all official records. Consequently, when applying for a correction of an official naval record, the burden is on the applicant to demonstrate the existence of probable material error or injustice.

2. Discussion: [REDACTED] enlisted in the Navy on 7 September 1988 for four years with a 12 month extension for the 5YO Electronics Technician Submarine school guarantee program. [REDACTED] states that he was guaranteed a 32 week advanced Electronic "A" school. However, per his enlistment contract [REDACTED] was only guaranteed to receive Basic Enlisted Submarine school, ET Core School, and a "C" school. [REDACTED] has completed all of the guaranteed training per his contract and received the appropriate Navy Enlisted Classification code. [REDACTED] had previously requested authority to cancel the 12 month extension but the request was disapproved by PERS 814 per GENADMIN 210658ZJAN99 and by PERS 4010 per GENADMIN 150957ZJAN99.

3. Recommendation: Recommend [REDACTED]'s request to cancel the 12 month extension be disapproved.
