- 1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to change the acceptance date (effective date for pay) of his original appointment as a limited duty officer (LDO) in the grade of captain from 4 December 2000 to 1 November 2000.
- 2. The Board, consisting of Messrs. Ensley, Pfeiffer and Taylor, reviewed Petitioner's allegations of error and injustice on , and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.
- 3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:
- a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.
- b. In correspondence attached as enclosure (2), the Headquarters Marine Corps office with cognizance over the subject matter of this case has commented to the effect that Petitioner's request has merit and warrants favorable action.

CONCLUSION:

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action.

RECOMMENDATION:

- a. That Petitioner's naval record be corrected, where appropriate, to show the acceptance date (effective date for pay) of his original appointment as an LDO in the grade of captain as 1 November 2000, vice 4 December 2000.
- b. That any material or entries inconsistent with the Board's recommendation be corrected, removed or completely expunged from Petitioner's record and that no such entries or material be added to the record in the future.
- 4. Pursuant to Section 6(c) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(c)) it is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above entitled matter.

MEMORANDUM FOR THE EXECUTIVE DIRECTOR, BOARD FOR CORRECTION OF NAVAL RECORDS

Subj: BCNR APPLICATION IN THE CASE OF CAPTAIN USMC

Ref: (a) MMER Route Sheet of 30 May 01

- 1. Per reference (a), Manpower Plans Division reviewed Captain s request for an effective back date of rank of 001101 and all pay and allowances paid once the correction is complete.
- 2. Captair was selected for appointment to limited duty officer (LDO) on the FY01 LDO Selection Board. Chief warrant officers selected to LDO are appointed as vacancies occur in the LDO MOS for which they were selected. Captain projected appointment date to the grade of captain was 010101. This was an incorrect projection. Captain should have been appointed on 001101.
- 3. In late November, Officer Plans (MPP-35) detected the error and coordinated with Marine Corps Recruiting Command (MCRC), Officer Appointments (OA) to send Captain his appointment package with a date of rank of 001101. The appointment package was received, executed, and returned to MCRC by Captain command, however, the original signed NAVMC 763 was received and reported with an effective date of 001204. Thus, pay and allowances did not start until 001204.
- 4. This error was not due to Captai actions, therefore, it is MP Division's opinion that Captain receive payment of all pay and allowances due with this effective date of rank.
