This is in reference to your application for correction of your naval record pursuant to the provisions of title 10 of the United States Code, section 1552.

A three-member panel of the Board for Correction of Naval Records, sitting in executive session, considered your application on 14 August 2001. Your allegations of error and injustice were reviewed in accordance with administrative regulations and procedures applicable to the proceedings of this Board. Documentary material considered by the Board consisted of your application, together with all material submitted in support thereof, your naval record and applicable statutes, regulations and policies. In addition, the Board considered the advisory opinion furnished by BUPERS memorandum 1160 PERS 815 of 13 July 2001, a copy of which is attached.

After careful and conscientious consideration of the entire record, the Board found that the evidence submitted was insufficient to establish the existence of probable material error or injustice. In this connection, the Board substantially concurred with the comments contained in the advisory opinion. Accordingly, your application has been denied. The names and votes of the members of the panel will be furnished upon request.

It is regretted that the circumstances of your case are such that favorable action cannot be taken. You are entitled to have the Board reconsider its decision upon submission of new and material evidence or other matter not previously considered by the Board. In this regard, it is important to keep in mind that a presumption of regularity attaches to all official records. Consequently, when applying for a correction of an official naval record, the burden is on the applicant to demonstrate the existence of probable material error or injustice.



1. In response to reference (a), recommend disapproval of the petitioner's request.

a. The petitioner reenlisted on 06 March 1998 for four years to have sufficient obliserve for BUPERS orders to BMU ONE CORANODO, CA. The petitioner's EAOS at the time of reenlistment was 26 December 1998.

b. The petitioner PCS for BUPERS orders in April 1998. The petitioner requests to receive a zone "A" SRB entitlement for the four year reenlistment of 06 March 1998 based on the SM(0000) rate.

c. Reference (b) released on 25 July 1997, with an effective date of 01 August 1997 did not list a SRB entitlement for the SM(0000) rate at the time the petitioner reenlisted. Reference (c), released on 20 November 1998, with an effective date of 01 December 1998 listed the SM(0000) rate as available for SRB reenlistment. Therefore, the petitioner is not eligible for the zone "A" SRB entitlement.

2. In view of the above, recommend the petitioner's record remain as is.
