1. Pursuant to the provisions of reference (a), Subject hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to show entitled to Basic Allowance for Housing (BAH) for his prior duty station.
2. The Board, consisting of Messrs. Agresti, Harrison, and Ms. Hare, reviewed Petitioner's allegations of error and injustice on 14 May 2002 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.
3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:
  - a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.
  - b. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

#### CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action.

RECOMMENDATION:


That Petitioner's naval record be corrected, where appropriate, to show that:

a. Petitioner was authorized BAH at the with dependent rate for his prior duty station effective 6 October 2001. Petitioner's prior duty station was USS Philippine Sea CG 58, FPO AA 34092-1178, which was homeported in Mayport, FL. Monthly mortgage payment is \$946.00.

b. That a copy of this Report of Proceedings be filed in Petitioner's naval record.
