- 1. Pursuant to the provisions of reference (a), Subject hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to show Enlistment Bonus (EB) entitlement..
- 2. The Board, consisting of Messrs. Leeman, Suiter, and Ms. Beckett, reviewed Petitioner's allegations of error and injustice on 26 November 2002 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.
- 3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:
- a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

## **CONCLUSION**

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action.

## **RECOMMENDATION:**

That Petitioner's naval record be corrected, where appropriate, to show that her enlistment in the Delayed Entry Program (DEP) on 23 October 2001 is under the provisions of the EB Program for the DK rating, BUPERS Mesage R 201100Z JUL 01, in the amount of \$5,000.00 based on a ship date of 5 December 2001 and further corrected to show that 5 December 2001 she executed a 12 month extension agreement in conjunction with her enlistment of 5 December 2001 to become operation on 5 December 2005.

- a. That a copy of this Report of Proceedings be filed in Petitioner's naval record.
- 4.
