REVIEW OF NAVAL RECORD

1. Pursuant to the provisions of reference (a), Subject's mother, hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to show enrollment in the Survivor Benefit Plan (SBP) under the insurable interest category, *vide* spouse and child.

2. The Board, consisting of Mr. Beckett, Ms. McCormick, and Ms. Nofziger, reviewed Petitioner's allegations of error and injustice on 17 September 2002 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and warrants favorable action.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action.

RECOMMENDATION:

That Subject's naval record be corrected, where appropriate, to show that:


a. Prior to her 1 May 1999 transfer to the Temporary Disability Retired List (TDRL) she enrolled in SBP under the insurable interest category, naming her mother, [REDACTED] as the beneficiary. Lance Corporal [REDACTED] enrollment for spouse and child coverage is null and void. She was automatically enrolled for spouse and child coverage but that enrollment was erroneous as she is single and has no children.

b. Lance Corporal [REDACTED] died on 14 September 1999.

c. That a copy of this Report of Proceedings be filed in Petitioner's naval record.


