REVIEW OF NAVAL RECORD

- 1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to show he was promoted to captain, pay grade O-3, in the Marine Corps Reserve, with a date of rank and effective date in July 1993.
- 2. The Board, consisting of Mses. Gilbert and Nofziger and Mr. Grover, reviewed Petitioner's allegations of error and injustice on 5 September 2003, and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.
- 3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:
- a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.
- b. In correspondence attached as enclosure (2), the Headquarters Marine Corps office with cognizance over the subject matter of this case has commented to the effect that Petitioner's request has merit and warrants favorable action. They concluded that he should have been promoted, while in the Individual Ready Reserve, with a date of rank (and by implication, effective date) of 1 July 1993.

CONCLUSION:

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action.

RECOMMENDATION:

- a. That Petitioner's naval record be corrected, where appropriate, to show he was promoted to captain, Marine Corps Reserve, with a date of rank and effective date of 1 July 1993; and that his grade upon discharge from the Marine Corps Reserve was captain.
- b. That a copy of this Report of Proceedings be filed at an appropriate location in Petitioner's naval record, and that another copy of this report be returned to this Board, together with any material directed to be removed from Petitioner's record, for retention in a confidential file maintained for such purpose.
- 4. Pursuant to Section 6(c) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(c)) it is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above entitled matter.



- 1. Reference (a) requested an advisory opinion in the case of Captain Captain S requesting that his record reflect his promotion to Captain in July 1993, while serving in the Inactive Ready Reserve (IRR).
- 2. The following facts are germane to this case:
- a. Captain esigned his regular commission and accepted a reserve commission in the IRR on 25 May 1993.
- b. Per reference (b), Captain was considered and selected to Captain before the FY03 USMC Captain Promotion Selection Board, which convened on 12 February 2002.
- c. Per enclosure (1), Captain as given constructive service credit on 18 July 1994, for his participation in the IRR. References (a) and (b) document that, while in the IRR, he received a lineal precedence and a 1 July 1993 date of rank to Captain.
- 3. Promotion Branch recommends that Captain record reflect him as a Captain with a DOR of 1 July 1993.
