1. Pursuant to the provisions of reference (a), Subject hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected to show entitled to Basic Allowance for Housing (BAH) for designated location of dependents.

2. The Board, consisting of Messrs. Cooper, Pfeiffer, and Zsalman, reviewed Petitioner's allegations of error and injustice on 19 August 2003 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. After reviewing the correspondence attached as enclosure (2), the Board concluded that the request has merit and warrants favorable action.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action.

RECOMMENDATION:

That Petitioner's naval record be corrected, where appropriate, to show that:


a. BuPers modified the orders which assigned Petitioner from the USS Vicksburg, homeported in Mayport, FL to the Trident Training Facility, Kings Bay GA to delete the funding citation. Petitioner was being reassigned within the same geographical area and was not authorized travel of dependents or to ship household goods at government expense.

b. Petitioner was authorized BAH for designated location of dependents effective 25 June 2003. Address of dependents is [REDACTED] 32246 and has a monthly rent payment of \$990.00.

c. That a copy of this Report of Proceedings be filed in Petitioner's naval record.


