1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with this Board requesting, in effect, that the applicable naval record be corrected by changing the acceptance date of his commission as an ensign, U. S. Navy Reserve, from 5 April 2010 to 1 March 2010, the day after his discharge from the Regular Navy; and showing that he was promoted to lieutenant junior grade with a date of rank and effective date of 28 March 2010.

2. The Board, consisting of Messrs. , and , reviewed Petitioner's allegations of error and injustice on 14 October 2010, and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, naval records, and applicable statutes, regulations and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. In correspondence at enclosures (2) and (3), the Navy Personnel Command offices with cognizance over the subject

matter of Petitioner's case have commented to the effect the request has merit and warrants favorable action.

CONCLUSION:

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosures (2) and (3), the Board finds the existence of an error and injustice warranting the following corrective action.

RECOMMENDATION:

a. That Petitioner's naval record be corrected, where appropriate, by changing the acceptance date of his commission as an ensign, U. S. Navy Reserve, from 5 April 2010 to 1 March 2010.

b. That his anniversary date and pay entry base date be adjusted accordingly.

c. That his record be corrected further to show he was promoted to lieutenant junior grade with a date of rank and effective date of 28 March 2010.

d. That a copy of this Report of Proceedings be filed at an appropriate location in Petitioner's naval record, and that another copy of this report be returned to this Board, together with any material directed to be removed from Petitioner's record, for retention in a confidential file maintained for such purpose.


